Additional comment/information: (to 1 Oct 2025)

GLAF Comment: “GLAF recommend that delegated powers be made the default for determination of DMMOs; however where cases are controversial or subject to many valid objections that they then should be reported to CROW Cttee for determination. This is a similar process to that used within planning applications.”

This recommendation has now been passed to the Council’s Democratic Services Unit (DemocraticServices@gloucestershire.gov.uk). They have advised that any proposed alteration to the terms of the Committee will need to be put to the Committee to explore and consider. If the CROW Committee recommends any change to its terms of reference, it would first require a formal Committee decision, which would then need to go to the Constitution Committee and, if agreed, then to full Council for a final decision.

CROW Committee and the elections:

First CROW Committee meeting of the new Administration will be held on Tuesday 7th October, with two applications being taken for determination.

Regulations (cut-off/DeReg, etc.):

No further known update in respect of England. However, the Welsh Senedd have now repealed the “cut-off” for Wales. It’s contained under Scheule 1, Part 15 of the attached:

GCC Area Officer Update

Louisa Rankin– North Cotswolds

- **HLO20 Longborough, Monarchs Way Bridleway:** Improvements funded by multiple sources including UKSPF, Cotswold Way Association, and local councils. The project focused on surfacing enhancements.



- **HEB31 Bridge:** A bridge improvement project on HEB 31, Ebrington



Will Saunder – Gloucester and North Forest

- **Staunton Bridleway GST29:** Safety and accessibility upgrades included resurfacing, a new bridle gate, culvert installation to prevent flooding, and a ramp onto the bridge. These changes addressed poor surface conditions and flooding issues.



Frank Dorrington Ward – Stroud East & South Cotswolds

- **Tetbury Trail:** 1.1 km of resurfacing on a popular multi-user path along the old railway line. The project was well received and funded by multiple trusts and GCC teams.



- **NAV 1 Bridleway (Avening):** 50m of bridleway resurfaced to eliminate a severe quagmire, reconnecting it to the wider bridleway network.



Hilary Grace – Cheltenham & Tewkesbury

- **ASM 14 Bridge at Southam:** Bridge replacement carried out by Cotswold Voluntary Wardens, with support from Rob (GCC Works Warden).



Sarah Macaulay-Lowe - Stroud Area (west of A46)

Gossington Bridleway CSL 16 - Wide, enclosed by hedges, bridleway which has a clay surface (low lying area). Very wet in the winter and dries to concrete in the summer. Report came in about a horse sinking over its hocks in clay.

We carried out some surface and drainage work to repair the surface and re-establish the ditches

5 new pedestrian bridges have been installed across the South Forest Area including this one on Public Footpath DBL28 near to Gaulett Farm on 2nd July. This replaced the broken and impassable one that we had not being able to access for the last two years, due to the wet ground conditions.
