

Key Points

Cheltenham

- Population of 0–18 year olds projected to reduce by 3,352 (13.7%) by 2035
- Number of suspensions have more than doubled in the past 5 years
- 20.9% of the population with an EHCP live in the most deprived areas compared with 12.4% of 0-24 year olds
- The rate of mental health related admissions into A&E is greater than the national average and CAMHS referrals for 5-11 year olds has increased by 80.5% since 2021-22

Gloucester

- Most deprived district in Gloucestershire and has the highest proportion of adults in the lowest social grade class
- Rate of CME is the highest in the county (80.6 per 10,000 0-18 year olds)
- Highest rate of CiN plans, early help episodes and single assessments in Gloucestershire.
- Number of single parents receiving universal credit has increased by over 50% since June 2021
- Highest rate of hospital admissions for dental carries in the county

Cotswold

- Lowest birth rate in Gloucestershire (0.69 per 100)
- Highest percentage of students missing more than 50% of available school sessions (4.22%)
- None of the population of 0-24 year olds live in the most deprived quintile
- Lowest employment rate in Gloucestershire of working aged individuals (69.9%)
- The rate of mental health related admissions into A&E is greater than the national average and CAMHS referrals for 5-11 year olds has increased by 106.5% since 2021-22

Stroud

- Least deprived district in Gloucestershire
- Number of suspensions has more than doubled in the past 5 years
- Highest rate in Gloucestershire of C&YP that are EOTAS (6.2/10,000)
- 18.4% of single assessments have a recorded outcome of 'Mental Health of Parent'
- Number of single parents receiving universal credit has increased by almost 60% since June 2021
- CAMHS referrals for 5-11 year olds has increased by 151.5% since 2021-22

Forest of Dean

- 2nd most deprived district in Gloucestershire.
- Number of suspensions has more than tripled in the past 5 years
- Highest rate of CP plans, Section 47 enquiries and supporting family's episode in Gloucestershire
- Rate of C&YP with an EHCP specifying SLCN as the primary need has nearly tripled since 2018
- 12.3% of families are living in fuel poverty which is the highest rate in Gloucestershire
- 22.9% of children in year 6 were considered obese in 2023

Tewkesbury

- Population of 16-18 year olds is lower in Tewkesbury compared with Gloucestershire
- Number of suspensions have almost tripled in the past 5 years
- Higher proportion of EHCP's in the school population compared with the rest of the county
- Number of single parents receiving universal credit has increased by almost 81% since June 2021
- CAMHS referrals for 5-11 year olds has increased by 106.5% since 2021-22




Social Grade Distribution (Census 2021)


Population Projections (0-18)

Population Pyramid (2024 MYE)







Students Reaching Expected Standard KS2





Count of Suspensions by Academic Year





Early Years Funding Uptake

During the 2024/25 academic year **75.89%** of eligible 2-year-olds in Cheltenham received funded early education which is **significantly higher** than Gloucestershire (**60.23%**). 





Rate of SLCN, MLD, SEMH and ASD per 10,000








Children under 16 in absolute low-income families





Family Households on Universal Credit






Pupils by Weight Classification (%)








Social Grade Distribution








Percentage of 5-year-olds at 'expected level' at the end of EYFS (2024/25)







Students Reaching Expected Standard KS2





Count of Suspensions by Academic Year














Children under 16 in absolute low-income families

Population Projections (0-18)




Social Grade Distribution





Population Pyramid by Age and Gender









Percentage of 5-year-olds at 'expected level' at the end of EYFS (2024/25)







Students Reaching Expected Standard KS2





Count of Suspensions by Academic Year










Children under 16 in absolute low-income families




Pupils by Weight Classification (%)

Population Projections (0-18) by School Age




Social Grade Distribution








Students Reaching Expected Standard KS2





Count of Suspensions by Academic Year










Social Grade Distribution



Population Pyramid by Age and Gender






Students Reaching Expected Standard KS2




Count of Suspensions by Academic Year


Social Grade Distribution

Population Pyramid by Age and Gender






Count of Suspensions by Academic Year



Rate of first-time entrants into the youth justice system per 100,000




