NOTICE is hereby given that Gloucestershire County Council intend to make a Variation Order under Sections 1, 2, 3, 4, 5, 32, 35, 36 and 39 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers, the effect of which would vary the Gloucestershire County Council On Street Parking Order 2017 (the 2017 Order) by introducing/revoking the proposed restrictions detailed in The Schedule below on the High Street in Tewkesbury, Gloucestershire.

High Street (A38)	Along a 10-metre section of the south-eastern side of the carriageway between Stephens Alley (60330) & Well Alley (60331)
