

**THE CITY OF GLOUCESTER
(EASTGATE STREET) (TRAFFIC REGULATION)
(AMENDMENT NO.2)
ORDER 2006**

The Council of the City of Gloucester, pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the Gloucestershire County Council, in exercise of the powers conferred on that County Council under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

PART I - GENERAL

1. This Order shall come into operation on the 15th day of ~~September~~ 2006 and may be cited as "The City of Gloucester (Eastgate Street) (Traffic Regulation) (Amendment No.2) Order, 2006".
2. The provisions of The City of Gloucester (Eastgate Street) (Traffic Regulation) Order 1989, as detailed in Schedule I to this Order, are hereby revoked.
3. The provisions of The City of Gloucester (Eastgate Street) (Traffic Regulation) Order 1989, as detailed in Schedule II to this Order, are hereby amended.
4. The provisions of The City of Gloucester (Eastgate Street) (Traffic Regulation) (Amendment #1) Order 1990 as detailed in Schedule III to this Order, are hereby amended.

SCHEDULE I - REVOCATIONS

The provisions of The City of Gloucester (Eastgate Street) (Traffic Regulation) Order 1989 Part V and Part VI are hereby revoked.

SCHEDULE II - AMENDMENTS

**THE CITY OF GLOUCESTER (EASTGATE STREET)
(TRAFFIC REGULATION) ORDER 1989**

The provisions of The City of Gloucester (Eastgate Street) (Traffic Regulation) Order 1989 Part II and Part III are hereby amended.

Part II

'Article 5'

Add:-

- (7) Nothing in Article 4 of this Order shall apply to the riding of a pedal cycle.

Part III

'Article 7'

Add:-

- (9) Nothing in Article 6 of this Order shall apply to the riding of a pedal cycle.

Part I

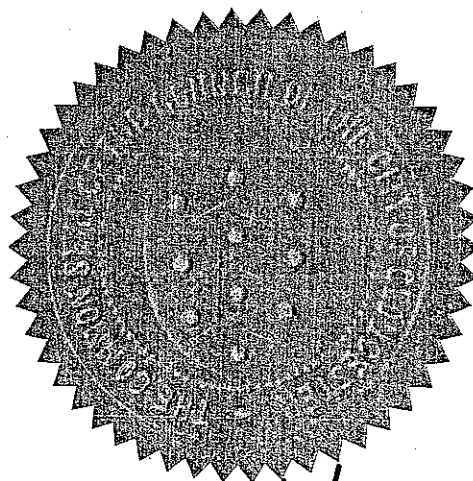
'Article 3'

Add:-

- (7) In this Order "pedal cycle" means a bicycle, tricycle or cycle having four or more wheels not being in any case a motor vehicle.
- (8) In this Order the distances given in the Schedule hereto are measured along the kerb of the roads specified therein.
