

PUBLIC NOTICE
GLOUCESTERSHIRE COUNTY COUNCIL
ON STREET PARKING ORDER 2017
(RESTRICTED PARKING ZONES EXCEPT IN SIGNED BAYS) (VARIOUS ROADS
WITHIN GLOUCESTER CITY) (VARIATION) ORDER 2018

NOTICE is hereby given that Gloucestershire County Council intend to make a Variation Order under the Road Traffic Regulation Act 1984, the effect of which would vary the Gloucestershire County Council On Street Parking Order 2017 (the 2017 Order) by:

1. Consolidating the restrictions described in Schedule 1 below; and
2. Introducing the proposed restrictions described in Schedule 2 below; and
3. Revoking the restrictions described in Schedule 3 below.
