

PUBLIC NOTICE
VARIATION OF
GLOUCESTERSHIRE COUNTY COUNCIL ON STREET PARKING ORDER 2017
BY AMENDING THE PLANS TO (REMOVE THE PERMIT HOLDER ONLY PARKING
RESTRICTIONS ALONG VARIOUS ROADS IN THE LANSDOWN WARD OF CHELTENHAM)
2019

NOTICE is hereby given that on the 17th January 2019 Gloucestershire County Council made a Permanent Variation under the Road Traffic Regulation Act 1984, the effect of which is to confirm the "Variation of Gloucestershire County Council On Street Parking Order 2017 By Amending the Plans To (Experimentally Remove the Permit Holder Only Parking Restrictions Along Various Roads in the Lansdown Ward of Cheltenham) 2017 which came into effect on 1st August 2017. The effect of this Permanent Variation is to permanently vary the Gloucestershire County Council On Street Parking Order 2017 ("the 2017 Order") by removing the Permit Holder Only parking restrictions along various roads in the Lansdown Ward of Cheltenham as described in the Schedule below:

THE SCHEDULE
Unrestricted Parking

Road name	Extent of restriction
Lansdown Place Lane	Entire length
Lansdown Crescent Lane	Entire length
Lansdown Walk	Entire length

These permit holder only restrictions were put in place by the Variation of Gloucestershire County Council (The Borough of Cheltenham) (Prohibition and Restriction of Waiting and Loading and Parking Places) Amendment (Consolidation) Order 2008 (By Amending the Plans to Prohibit and Restrict the Waiting, Loading and Parking Places along Various Roads within and Adjacent to Zone 13 (Z13), Lansdown, Cheltenham) 2016. The relevant restrictions will be permanently revoked from the 1st February 2019.

Please note that the newly implemented parking bays restricted to Permit Holders or Limited Waiting 4 hours will remain in place.

1. The 2017 Order will be varied by the attachment thereto of the Plans annexed to this Notice (which identify the roads or sides of roads to which the removal of parking restrictions affect).
2. This Permanent Variation shall come into operation on the 1st February 2019 and may be cited as the Variation of Gloucestershire County Council On Street Parking Order 2017 By amending the Plans to (Remove the Permit Holder Only Parking Restrictions along Various Roads in the Lansdown Ward of Cheltenham) 2019.

The lengths of roads fall in the Lansdown Ward within the boundary of Cheltenham Borough in the County of Gloucestershire.

The usual exemptions will apply to Statutory Undertakers and Local Authority vehicles carrying out duties in exercise of their statutory powers, and also in the case of emergency services vehicles and disabled persons vehicles.

A copy of the Sealed Plans to be inserted into the Schedule of Plans together with a copy of the Statement of Reasons, may be inspected during normal opening hours at Gloucestershire County Council, Map Room, Shire Hall, Gloucester GL1 2TG and Cheltenham Library, Clarence Street, Cheltenham, GL50 3JT or can be viewed at <http://www.gloucestershire.gov.uk/parking> (please quote reference HBL/64171).

Any person wishing to question the validity of the Permanent Variation or any provision contained in it on the ground that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the ground that any requirement to that Act or any Statutory Instrument made under it

has not been complied with in relation to the Permanent Variation may within six weeks of the date on which the Permanent Variation is made, apply to the High Court for this purpose.
