PUBLIC INQUIRY TO BE HELD AS A VIRTUAL EVENT

NOTICE is hereby given that Public Local Inquiry in connection with the Order mentioned below, will be held by an Inspector appointed for this purpose by the Secretary of State for Transport, and will **begin at 10:00 am on Tuesday 24 November 2020**. The Inquiry will be held as a virtual event, run by an Inspector in the normal way but with the parties invited to join via Microsoft Teams or telephone.

The Inquiry is being held to hear representations about the Order from remaining objectors (as defined in the Compulsory Purchase (Inquiries Procedure) Rules 2007), from any other persons having an interest in the land the subject of the Compulsory Purchase Order and, at his discretion, to hear representations from any other persons who may desire to appear and be heard.

The Order has been made by Gloucestershire County Council under the above-mentioned Acts and submitted to the Secretary of State for Transport for confirmation and is:

GLOUCESTERSHIRE COUNTY COUNCIL GLOUCESTER SOUTH WEST BYPASS (LLANTHONY ROAD SECTION) COMPULSORY PURCHASE ORDER 2019. This is an Order under Sections 239 and 246 of the Highways Act 1980.

THE ORDER relates to the improvement of the north eastern section of the A430 Hempsted Lane and Llanthony Road from its junction with St Ann Way to Castlemeads Way, Gloucester.
