ON-STREET PARKING ORDER 2017

(SCHOOL STREETS - VARIOUS ROADS SURROUNDING WARDEN HILL PRIMARY SCHOOL AND TEWKESBURY C OF E PRIMARY SCHOOL) (CHELTENHAM BOROUGH AND TEWKESBURY BOROUGH) (EXPERIMENTAL VARIATION) ORDER 2020

Gloucestershire County Council in exercise of its powers under sections 1, 2, 4, 9, 10, 32, 35, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the 1984 Act) and the Traffic Management Act 2004 (the 2004 Act) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Experimental Variation Order.

1. The Gloucestershire County Council On-Street Parking Order 2017 (“the 2017 Order”) shall be amended by the revocation of the existing sealed plans specified in the First Schedule to this Experimental Variation Order and which are hereby replaced with the new sealed plans specified in the Second Schedule to this Experimental Variation Order.
2. The effect of this Experimental Variation Order is to experimentally introduce the restrictions set out in the Third Schedule to this Experimental Variation Order which will experimentally replace the restrictions set out in the Fourth Schedule to this Experimental Variation Order.

3. The remainder of the 2017 Order shall remain in full force and effect including any restrictions that have not been experimentally suspended by this Experimental Variation Order
4. Under Section 10(2) of the Road Traffic Regulation Act 1984, Gloucestershire County Council may modify or suspend the operation of the Experimental Variation Order or any provision of it if it appears essential (a) in the interest of the expeditious, convenient and safe movement of traffic (b) in the interest of providing suitable and adequate on-street parking facilities or (c) for preserving or improving the amenities of the area through which any road affected by the Experimental Variation Order runs. This power shall be exercised only after consulting the appropriate Chief Officer of Police and giving such public notice as the Secretary of State may direct
5. The Experimental Variation Order is Experimental and may continue in force for a period of 18 months up to 1st May 2022. In due course the Council will consider whether or not the provisions of the Experimental Variation Order should continue in force indefinitely
6. This Order shall come into effect on the 2nd November 2020 and may be cited as "The Gloucestershire County Council On-Street Parking Order 2017 (School Streets - Various

Roads Surrounding Warden Hill Primary School and Tewkesbury C of E Primary School)
(Cheltenham Borough and Tewkesbury Borough) (Experimental Variation) Order 2020".
