

**GLOUCESTERSHIRE COUNTY COUNCIL TEMPORARY ROAD ORDER**  
**A46 COLLEGE ROAD AND 490347 KEYNSHAM ROAD**  
**(COLLEGE WARD) CHELTENHAM BOROUGH 2021**

WHEREAS the Gloucestershire County Council ("the Council") being the Traffic Authority for the roads as described in Schedule 1 ("the Schedule 1 Roads") and Schedule 2 ("the Schedule 2 Roads") below (collectively known as "the Roads") is satisfied that the current restrictions along the Roads can be temporarily suspended and new restrictions temporarily implemented to assist Cheltenham General Hospital NHS staff in finding a parking space during the Coronavirus pandemic.

NOW THEREFORE the Council in exercise of its power under Sections 14, 15 and 16 of the Road Traffic Regulation Act, 1984, as amended, hereby makes the following Order:

1. The current restrictions on the Schedule 1 Roads as detailed in Schedule 1 below are hereby suspended for the duration of this Temporary Order and will be indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2016 ("TSRGD 2016");
2. No person shall park nor wait nor load or cause anyone to park or wait or load along the Schedule 2 Roads unless it is in accordance with the restrictions described in Schedule 2 below throughout the duration of this Temporary Order;
3. The restrictions on the Schedule 2 Roads shall only operate when indicated by traffic signs prescribed by TSRGD 2016;
4. Nothing in Article 2 shall render it unlawful for a vehicle being used for Police, Fire Brigade or Ambulance purposes to park along the Schedule 2 Roads;
5. Nothing in Article 2 shall render it unlawful for a vehicle being used by a statutory undertaker responding to an emergency situation to park along the Schedule 2 Roads;
6. The Roads fall in the College Ward in the Cheltenham Borough in the County of Gloucestershire;
7. This Order shall come into operation on the 12<sup>th</sup> day of February 2021 and shall continue in force for a period not exceeding eighteen months from the date when the Schedule 1 Roads were suspended and the Schedule 2 Roads restricted by Notice on 8<sup>th</sup> February 2021;
8. This Order may be cited as "Gloucestershire County Council Temporary Road Order A46 College Road and 490347 Keynsham Road (College Ward) Cheltenham Borough 2021"
9. In the event of any inconsistency or ambiguity between the content of this Temporary Order and any existing permanent/experimental Order(s) imposing restriction(s) on the Roads the latter will be suspended for the duration of this Temporary Order and the provisions of this Temporary Order shall prevail during that period.
