NOTICE OF MAKING OF A PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER HIGHWAYS ACT 1980 WILDLIFE AND COUNTRYSIDE ACT 1981 GLOUCESTERSHIRE COUNTY COUNCIL (PUBLIC FOOTPATH CWE 69) (PARISH OF WOTTON UNDER EDGE) DIVERSION ORDER 2020

The above Order made on the 30th January 2020 under Section 119 of the Highways Act 1980, and Section 53A(2) of the Wildlife and Countryside Act 1981, if confirmed, will divert the length of Public Footpath described in Part 1 of the Schedule hereto to a line described in Part 2. If no such representations or objections are duly made, or if any so made are withdrawn, Gloucestershire County Council may confirm the Order as an unopposed Order. If the Order is sent to the Secretary of State for the Environment for confirmation, any representations and objections that have not been withdrawn will be sent with the Order. In submitting an objection it should be noted that personal data and correspondence relating to any objection will be passed to Gloucestershire County Council in order that they can contact you directly to address the issues raised. If any person does not wish personal data to be forwarded to the Council they should state why when submitting the objection and the Secretary of State will copy the representations to the Council with the name and address removed and if there is to be a public inquiry the representations will be seen by the Inspector who may give them less weight as a result.
