Welcome and Actions

- Mark Hawthorne welcomed the group and discussed the actions of the previous meeting.

Refugee and Asylum seeker accommodation

- Pete Bungard provided an update on the residents that remain in hotels and noted ongoing high demand.
- An update was received on accommodation at Wheatridge court with current occupancy at 24 residents out of a capacity of 30.
- A progress update on the Homes for Refugees scheme was given with 5 matches being found.
- Proposal submission for short term cost sharing to be formalised at a meeting on March 18th. **ACTION:** Peter Tonge to provide an update post the meeting of the section 151 officers regarding collaboration and support for accommodation.

- Peter Tonge provided update on the Action to contact ClearSprings stating thus far they have not picked up the phone **ACTION:** Exploration of alternate ways to get in contact to be considered.
- Districts are still considering modular housing.

Stronger Local Resilience Forum

- Mandy Quayle introduced the SLR pilot, emphasising its aim to promote a whole-society approach towards resilience.
- Funding details and the involvement of Leadership Gloucestershire for oversight was discussed.
- A Stakeholder event is scheduled in the coming weeks to gather feedback and engagement.

County Deals

- Pete Bungard provided an update on devolution deals.
- Anticipation of the announcement of deals for three councils, however Gloucestershire is not anticipated to be one of them.

City Region Board

- The group was informed that the approval process is ongoing with an informal scrutiny committee meeting set for next week (w/c March 11).
- A proposed meeting date in June for the City Region Board was discussed.

Western Gateway

- An update was given on interviews for a new chair.
- The launch of the Severn Estuary Commission next week was discussed, focusing on energy projects.
- Progress on appointing commissioners and the shifting responsibilities of the steering group was outlined.

One Gloucestershire

- Mary Hutton provided detailed updates on healthcare planning, highlighting challenges posed by an ageing population.
- A discussion was held on the need for more care homes and flexible housing options.
- An agreement was reached to examine demographic changes and the challenges that this brings in more detail as an action item. **ACTION:** Relevant parties to discuss moving this forward.
