ORDER 2025**

Gloucestershire County Council in exercise of its powers under Sections 1, 2, 3, 4 & 5 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the 1984 Act) and the Traffic Management Act 2004 (the 2004 Act) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order.

1. The Gloucestershire County Council On-Street Parking Order 2017 ("the 2017 Order") shall be amended by the insertion of the sealed plan(s) specified in the First Schedule to this Order.
2. The effect of this Order is to introduce the restrictions set out in the Second Schedule to this Order.
3. The remainder of the 2017 Order shall remain in full force and effect.
4. This Order shall come into effect on the **day of 2025** and may be cited as the "GLOUCESTERSHIRE COUNTY COUNCIL ON STREET PARKING ORDER 2017 (VARIOUS ROADS IN THE TWIGWORTH GREEN PHASE 1A DEVELOPMENT) (PARISH OF TWIGWORTH) (TEWKESBURY BOROUGH) (VARIATION) ORDER 2025"

Barley Drive (82308)	Along sections on both sides of its carriageway north-east of its junction with Ironbridge Road (82319)  Along sections on both sides of its carriageway north east of its internal junction along the section of carriageway on approach to the Twigworth Local Centre
Leighton Close (82320)	Along a section on both sides of its carriageway at its junction with Ironbridge Road (82319)  Along a section on both sides of its carriageway at its internal loop road junction.
Carrington Road (82322)	Along a section on both sides of its carriageway at its junction with Ironbridge Road (82319)
