Training

We have opened up our inclusion needs you training to all providers delivering Wraparound.

This training will allow you to gain the skills and confidence to welcome and include disabled children (including those with physical, sensory or cognitive conditions, neurodiversity, SEN and additional needs) at your Wraparound Care Setting. Inclusion Needs You is led by a team of two trainers with a variety of lived experience, including disabled and neurodivergent trainers and parent carers.

The next two day inclusion training will take place in Cirencester on 6 and 20 May 2025. This programme has spaces reserved for Wraparound Care providers. If these are sold out you can still book onto the general ticket spaces. However, tickets are set to one per booking. This is because we'd like every participant to make their own booking so they individually receive all the advance information. If you are booking on behalf of your staff please do this as separate orders and use their emails so they get the information directly.
