This session will explore how we can talk with babies to help them become confident communicators and develop respectful relationships that enable them to make genuine choices. We will explore the benefits of 'contingent talk' with younger children and how high-quality adult/child interactions and planning for talk can be part of everyday practice. ## **Early Years SENCO - Level 3 - Best Practice Network**

As part of the government's plan to break down barriers to opportunity, improving outcomes for children in early years education, the Department for Education is very pleased to announce that Best Practice Network (BPN) has been selected as our delivery partner to provide 1000 SENCO training places in financial year 2025-26.

The key aim of the programme is to increase the number of qualified SENCOs available to children in group-based settings and childminder settings, who have the knowledge and skills to properly fulfil the role of a SENCO described in the [code of practice and in the role description](#).

Training is available across England and is open to Early Years educators currently working as, or due to start working as, a Special Educational Needs Coordinator in their setting.

Applicants from group-based private, voluntary or independent (PVI) settings must hold a full and relevant level 3 Early Years qualification. Childminder applicants must hold either a full and relevant Early Years level 3 qualification or have a level 2 Early Years qualification but have fully completed at least one level 3 Early Years training module and have significant experience of working in Early Years.

## **Spending Review - Early Education and Childcare Coalition**

Ahead of the upcoming Spending Review in June, where the government will outline its future spending plans, the Alliance are working with the Early Education and Childcare Coalition to build as strong a case as possible for greater support for early years providers.

As part of this work, the Coalition has launched a short survey which aims to capture the true impact of recent cost pressures, including national minimum wage rises and changes to employer national insurance contributions, on early years settings now that these changes have come into effect.

The results of the survey will be used alongside a new independent research report commissioned by the Coalition to support the ongoing campaign for better funding for the sector ahead of the Spending Review.

They are asking as many early years settings as possible to respond to the survey, which should only take around 5 minutes. [Provider Survey](#)
