This week Ofsted published their [new guidance](#) for inspectors and providers on inspecting registered early years settings in England under the renewed education inspection framework. This guidance will replace the Early Years Inspection Handbook from 10th November 2025.

## CON Week 2025 – Supporting Parents, Protecting Babies

*"Babies cry, you can cope!"*

This September, NHS services, local authorities, charities and healthcare organisations across the country will join together once again to share important messages with parents and carers during **ICON Week 2025 - 22nd to 26th September**.

Now in its fourth year, ICON Week will focus on *mental health and staying calm*. The campaign reminds parents that infant crying is normal, provides practical coping strategies, and raises awareness of the dangers of shaking a baby. This year, ICON Week is also highlighting that coping with crying is an issue for **both men and women**.

The ICON programme is built around a simple, evidence-based message:

**I** – Infant crying is normal and will stop

**C** – Comfort methods can sometimes soothe the baby

**O** – It's OK to walk away for a few minutes if the baby is safe and the crying feels overwhelming

**N** – Never shake or hurt a baby
