

Ofsted: Explore an Area

Ofsted will be discussing the context of your setting with you during your inspection, they will not expect all settings to be mirroring the information in the local area data, but they will expect you to understand the context of the area you are working in. This includes your own knowledge and experiences of your locality and the families you work with.

If you search by local authority, you can view information about factors such as the number of children living in income-deprived families, rates of obesity, and poor oral health. These will form a discussion point when Ofsted talk to you about your setting
