

**GLOUCESTERSHIRE COUNTY COUNCIL  
(30MPH & 40MPH SPEED LIMITS) (B4063 GLOUCESTER ROAD/CHELTHENHAM  
ROAD EAST AND SURROUNDING AREA) (PARISHES OF STAVERTON,  
INNSWORTH AND CHURCHDOWN) (CHELTHENHAM BOROUGH, GLOUCESTER  
CITY AND TEWKESBURY BOROUGH) ORDER 2025**

The Gloucestershire County Council ("the Council") in exercise of its powers under Sections 81, 82, 83 and 84 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 of the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of that Schedule hereby make the following Order:-

1. (i) This Order shall come into operation on the 17<sup>th</sup> January 2025 and may be cited as the "Gloucestershire County Council (30mph & 40mph Speed Limits) (B4063 Gloucester Road/Cheltenham Road East and Surrounding Area) (Parishes of Staverton, Innsworth and Churchdown) (Cheltenham Borough, Gloucester City and Tewkesbury Borough) Order 2025" ("the Order")
 

(ii) The Order affects roads within the Parishes of Innsworth, Staverton and Churchdown, the Wards of Hesters Way, Badgeworth, Churchdown St Johns, Longlevens and Innsworth within the Tewkesbury Borough, Cheltenham Borough and Gloucester City in the County of Gloucestershire.
2. In this Order –
 

"Motor Vehicle" means a mechanically propelled vehicle intended or adapted for use on the roads as defined in Section 185 of the Road Traffic Act 1988.
3. No person shall cause or permit any Motor Vehicle to proceed along that length of road described in the First Schedule to the Order at a speed exceeding 30 MPH.
4. No person shall cause or permit any Motor Vehicle to proceed along that length of road described in the Second Schedule to the Order at a speed exceeding 40 MPH.
5. No speed limit imposed by the Order applies to vehicles falling within Regulation 3(4) of the Road Traffic Exemption (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those regulations.
6. The orders specified in the Third Schedule to the Order are hereby revoked in full.

**FIRST SCHEDULE**  
**30MPH SPEED LIMIT TO BE INTRODUCED**

Pheasant Lane (400382)	From its junction with B4063 Gloucester Road for approximately 50 metres in an easterly direction.

**SECOND SCHEDULE**  
**40MPH SPEED LIMIT TO BE INTRODUCED**

Cheltenham Road East (B4063)	From a point approximately 154 metres north-east of its junction with Nine Elms Road to a point approximately 155 metres north-east of its junction with A40 Elmbridge Court roundabout.
