INTRODUCTION

The Unemployment Bulletin provides a monthly update on unemployment data for Gloucestershire, the South West region and the United Kingdom. It is produced by the Economic section of the County Council Chief Executive's Support Unit Research Team. The data is sourced from the Office for National Statistics via Nomis (www.nomis.co.uk).

The claimant count measures the number of people claiming unemployment-related benefit (currently Job Seeker's allowance). The claimant rate is the number of claimants as a proportion of the working age population.


PART 1: SUMMARY

The claimant rate in Gloucestershire was 3.2% in February 2009. This was an increase of 0.5% on the January 2009 figure. The rate has been continually increasing since July 2008. The UK rate has increased by 0.5% between January and February 2009 with the South West rate increasing by 0.4. Gloucestershire's rate remains slightly above the South West average of 2.9%, but 0.7% lower than the UK average of 3.9%.

The claimant count in Gloucestershire in February 2009 rose by 1,743 people. The amount of people claiming in February 2009 was 18% higher than the number in January 2009 equalling a 19% increase in the South West and 14% for the UK.

The claimant count in Gloucestershire has been increasing since July 2008, it was 113% higher in February 2009 than at the same point in the previous year as shown in the graph below.

YOUNG PEOPLE NOT IN EDUCATION, EMPLOYMENT OR TRAINING (NEET)

At the end of February 2009 there were 659 young people aged 16-18 not in education, employment or training in Gloucestershire. This figure translates into an adjusted (*) 16-18 NEET population of 4.0% which shows an increase of 0.3% from last month. Analysis of numbers of NEET joiners in recent months reflects a 30-40% increase compared to the same period in 2008.

PART 2: UK, SW AND GLOUCESTERSHIRE INDICATORS

The unemployment situation in Gloucestershire compared to the South West and the UK.

Claimant Rate

Figure 1: Claimant Rate for Gloucestershire, the South West and UK over the past year




Figure 1 shows the claimant rate for Gloucestershire at 3.2% in February 2009. The rate has remained slightly higher than the South West average over the past year, but persistently lower by approximately 0.7% against the UK average during the same period. February 2009 represented a 0.5% increase on January 2009.

Table 1 shows that in February 2009, the numbers of claimants in Gloucestershire was 18.4% higher than the numbers in January 2009. This is 4.4% higher than the UK figure and 0.8% lower than the South West.

The average growth in claimants in Gloucestershire for the six months to February 2009 was 9.8%. This is 2.3% higher than the UK average and 1.1% lower than the South West region.

Figure 2: Claimant Rate (%) across Gloucestershire - February 2009




Figure 2 shows the claimant rate for February 2009 in Gloucestershire. Every district in Gloucestershire experienced an increase in the claimant rate between January 2009 and February 2009.

Figure 3: Total claimants over the past year across Gloucestershire Districts




Figure 3 shows the overall claimant count for Gloucestershire over the past year. It demonstrates the gap that is widening across all the districts as the UK economy continues in recession. The widest gaps unsurprisingly reflect the urban areas of Cheltenham and Gloucester.

Table 2 shows the change in the claimant count in February 2009 compared to January 2009. The February 2009 increase was experienced across all six districts. Stroud District showed the greatest percentage increase from the previous month and the highest average percentage increase over the last six months.

Figure 4: Cheltenham Borough claimant rate over the last year




Figure 4 shows the claimant rate in Cheltenham was at its highest for over a year at 3.6%. The rate has been climbing for ten consecutive months.

Figure 5: Cheltenham Borough claimants - Month on Month and Year on Year change




Figure 5 shows the claimant count continually increasing each month since July 2008. In addition, claimant counts have increased every month compared to the same month in the previous year since July 2008.

Figure 6: Claimant rates across Cheltenham Borough wards - February 2009






Figure 7 shows the claimant rate in Cotswold District was at its highest for over a year at 1.9%. The rate has been increasing since June 2008.


Figure 8: Cotswold District claimants - Month on Month and Year on Year change

Figure 9: Claimant rates across Cotswold District wards - February 2009





Figure 9 shows the claimant rates for Cotswold District wards. The red line represents the average claimant rate across the District. Eight wards lie above the District average of 1.9%.

Figure 10: Forest of Dean District claimant rate over the last year




Figure 10 shows the claimant rate in the Forest of Dean was at its highest for over a year at 3.5%. The rate has been increasing since July 2008.

Figure 11: Forest of Dean District claimants - Month on Month and Year on Year change



Figure 12: Claimant rates across Forest of Dean District wards - February 2009




Figure 13: Gloucester City claimant rate over the last year




Figure 13 shows the claimant rate for Gloucester City was at the highest point for over a year at 4.2%. The rate has been increasing since May 2008.

Figure 14: Gloucester City claimants - Month on Month and Year on Year change



Figure 15: Claimant rates across Gloucester City wards - February 2009





Figure 15 shows the claimant rates for Gloucester City district wards. The red line represents the average claimant rate across the City. Seven wards are above the City average of 4.2%.

Figure 16: Stroud District claimant rate over the last year




Figure 16 shows the claimant rate for Stroud District was at 2.6%, the highest it has been for over two years.

Figure 17: Stroud District claimants - Month on Month and Year on Year change



Figure 18: Claimant rates across Stroud District wards - February 2009




Figure 18 shows the claimant rates in Stroud District wards. The red line represents the average claimant rate across the District and eleven of the wards are above the District average of 2.6%.





Figure 19 shows the claimant rate for Tewkesbury District was at 2.7%, the highest it has been for over a year.


Figure 20: Tewkesbury District claimants - Month on Month and Year on Year change

Figure 21: Claimant rates across Tewkesbury District wards - February 2009




PART 5: YOUNG PEOPLE NOT IN EDUCATION, EMPLOYMENT OR TRAINING (NEET) IN GLOUCESTERSHIRE

Data provided by Prospects, the Connexions service in Gloucestershire on the situation of young people (16-18) in Gloucestershire who are not in education, employment or formal training.

Connexions Gloucestershire is required to report performance with the 16-18 age range against nationally defined criteria for counting the NEET group. The NEET group includes young people actively seeking education, employment or training as well as those young people who are either not yet ready or who are unable to access these opportunities because of their personal circumstances. The figures quoted below include young people in both of these categories.

SUMMARY

As at the end of February 2009 there were 659 young people aged 16-18 not in education, employment or training in Gloucestershire. This figure translates into an adjusted (*) 16-18 NEET population of 4.0% and this shows an increase from the 3.7% achieved at the end of January 2009. We are also reporting increases in the numbers of NEET young people in all Districts with the most significant increase being in Tewkesbury. Analysis of the numbers of NEET joiners in recent months is also evidencing a 30-40% increase based against the same period in 2008.

Analysis of our NEET group

We are working closely with key stakeholders and partners to ensure that we provide the best possible support during these challenging times. We have already published some evidence of the impact of the recession on NEET young people and have just completed a review of the NEET group in Gloucestershire to help us target the right support in the right places. Using criteria from a recent DCSF report we have categorised NEET into the following sub-groups;

- **Open to learning NEET** – short term and likely to re-engage – approx 55% of our NEET group are in this category and should, with the right support along with the right opportunity, be able to re-engage in learning
- **Sustained NEET** – long term with a range of personal issues/barriers – approx 30% of our NEET group are in this category and will need intensive support and specific provision to help them to re-engage
- **Undecided NEET** – young people who have several episodes within the NEET group – approx 15% of our NEET group are in this category and, like the sustained NEETs, will need enhanced support to help them to enter and remain in a positive outcome
