CLEEVE CYCLEWAY – SECTION 2.2 (SOUTH) SWINDON LANE ROUNDABOUT TO
GLOUCESTERSHIRE & WARWICKSHIRE STEAM RAILWAY BRIDGE MAJOR PROJECT
2025 (PRESTBURY WARD) (CHELTENHAM BOROUGH)

Notice is hereby given that Gloucestershire County Council in exercise of its enabling powers under Sections 65, 66 and 90A of the Highways Act 1980 intends:

1. To introduce flat-topped road humps as part of a continuous footway crossings as described in the Schedule below; and
2. To make improvements to the existing A435 Evesham Road Cycle Route by upgrading parts of the existing footways/verges and carriageways with sections of shared use footways/cycleways and segregated footways/cycleways on the eastern side between the Swindon Lane (Racecourse) Roundabout and the Gloucestershire and Warwickshire Steam Railway Bridge.
