**CITY) (VARIATION) ORDER 2025**

NOTICE is hereby given that Gloucestershire County Council intend to make a Variation Order under Sections 1, 2, 3, 4 & 5 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers, the effect of which would vary the Gloucestershire County Council On Street Parking Order 2017 (the 2017 Order) by introducing the proposed restrictions detailed in The Schedule below on various roads in Quedgeley Town, Gloucestershire.

***No Stopping on School Entrance Markings Mon-Fri 8am-4pm***

School Lane (486015)	Along sections on both sides of its carriageway north-east of its junction with Ashleworth Gardens (486003)

***No Waiting/No Loading Mon-Fri 7.30am-9.30am and 2pm-4pm (Single Yellow Lines with Single Kerb Blips)***

<b>Road Name &amp; Number</b>	<b>Extent</b>
Guise Close (407673)	Along sections on both sides of its carriageway north-west of its junction with Hadow Way (407671)
Knollys End (407675)	For its entire length on both sides of the carriageway
Giles Cox (407674)	Along sections on both sides of the carriageway north-west and south-east of its junction with Hadow Way (407671)
Hadow Way (407671)	Along sections on both sides of the carriageway at its junction with Giles Cox (407674)

The lengths of roads fall within the Town of Quedgeley within the City of Gloucester in the County of Gloucestershire.
