INTRODUCTION

The Unemployment Bulletin provides a monthly update on unemployment data for Gloucestershire, the South West region and the United Kingdom. It is produced by the Economic section of the County Council Chief Executive's Support Unit Research Team. The data is sourced from the Office for National Statistics via Nomis (www.nomis.co.uk).

The claimant count measures the number of people claiming unemployment-related benefit (currently Job Seeker's allowance). The claimant rate is the number of claimants as a proportion of the working age population.


PART 1: SUMMARY

The claimant rate in Gloucestershire was 2.6% in November 2011. This was the same as the October 2011 figure. The UK rate also remained the same as last month at 3.9%, while the South West rate increased by 0.1% last month to 2.7%. Gloucestershire's rate was 0.1% lower than the South West average of 2.7%, and 1.3% lower than the UK average of 3.9%.

The claimant count in Gloucestershire in November 2011 increased by 42 people. The amount of people claiming in November 2011 was 0.4% higher than the number in October 2011. This compares to a 1.8% increase in the South West and a -0.2% decrease for the UK.

The year on year claimant count in Gloucestershire has increased. The count was 11.8% higher in November 2011 than at the same point in the previous year as shown in the graph below.

YOUNG PEOPLE NOT IN EDUCATION, EMPLOYMENT OR TRAINING (NEET)

As at the end of November 2011 there were 891 young people aged 16-18 not in education, employment or training in Gloucestershire and this figure translates into an adjusted (*) 16-18 NEET population of 5.5%.

Claimant Rate

Figure 1: Claimant Rate for Gloucestershire, the South West and UK over the past year




Figure 1 shows the claimant rate for Gloucestershire at 2.6% in November 2011. Between July and November 2011, the rate remained the same as the South West average, in November 2011 it fell below the South West rate. It has been lower by approximately 1.3% against the UK average during the same period. The November 2011 rate remained the same as October 2011.

Table 1 shows that in November 2011, the number of claimants in Gloucestershire was +0.4% higher than the number in October 2011.

The average change in claimants in Gloucestershire for the six months to November 2011 was +2.0%. This is 1.3% higher than the UK average and 0.4% higher than the South West average.

Figure 2: Claimant Rate (%) across Gloucestershire - November 2011




Figure 2 shows the claimant rate for November 2011 in Gloucestershire. Between October 2011 and November 2011 Cotswold experienced an increase, while Tewkesbury declined and the remaining districts stayed the same.

Figure 3: Total claimants over the past year across Gloucestershire Districts




Figure 3 shows the overall claimant count by district over the past year. The number of claimants generally declined between November 2010 and June 2011. Since July 2011 the number of claimants have been increasing, with the exception of November when there was a small decline.

Figure 4: Cheltenham Borough claimant rate over the last year




Figure 4 shows the claimant rate in Cheltenham remained the same as the last two months at 3.0%.

Figure 5: Cheltenham Borough claimants - Month on Month and Year on Year change




Figure 5 shows the claimant count increased by +0.2% since last month. The change on the previous year has increased in November 2011 compared to October 2011 to +10.9%.

Figure 6: Claimant rates across Cheltenham Borough wards - November 2011







Figure 8: Cotswold District claimants - Month on Month and Year on Year change

Figure 9: Claimant rates across Cotswold District wards - November 2011







Figure 11: Forest of Dean District claimants - Month on Month and Year on Year change

Figure 12: Claimant rates across Forest of Dean District wards - November 2011







Figure 14: Gloucester City claimants - Month on Month and Year on Year change

Figure 15: Claimant rates across Gloucester City wards - November 2011







Figure 17: Stroud District claimants - Month on Month and Year on Year change

Figure 18: Claimant rates across Stroud District wards - November 2011







Figure 20: Tewkesbury District claimants - Month on Month and Year on Year change

Figure 21: Claimant rates across Tewkesbury District wards - November 2011







Claimant unemployment rate by LSOA in Gloucestershire November 2011




PART 6: YOUNG PEOPLE NOT IN EDUCATION, EMPLOYMENT OR TRAINING (NEET) IN GLOUCESTERSHIRE

Data provided by Prospects, the Connexions service in Gloucestershire on the situation of young people (16-18) in Gloucestershire who are not in education, employment or formal training.

Connexions Gloucestershire is required to report performance with the 16-18 age range against nationally defined criteria for counting the NEET group. The NEET group includes young people actively seeking education, employment or training as well as those young people who are either not yet ready or who are unable to access these opportunities because of their personal circumstances. The figures quoted below include young people in both of these categories.

Summary

As at the end of November 2011 there were 891 young people aged 16-18 not in education, employment or training in Gloucestershire and this figure translates into an adjusted (*) 16-18 NEET population of 5.5%. The total number of NEET decreased by 62 young people in November 2011 compared to October 2011. All districts saw a decrease in their NEET figure.
