

**PUBLIC NOTICE**  
**GLOUCESTERSHIRE COUNTY COUNCIL**  
**(30 MPH & 40MPH SPEED LIMITS) (A417 GLOUCESTER ROAD) (PARISH OF HARTPURY)**  
**(FOREST OF DEAN DISTRICT) ORDER 2025**

Notice is hereby given that Gloucestershire County Council in exercise of its enabling powers under Section 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 intends to make the above-named order the effect of which will be:

1. To introduce a north-westerly extension to the existing 30mph speed limit on A417 Gloucester Road by revoking the existing 40mph speed limit and introducing a 30mph speed limit as detailed in Schedule 1 below; and
2. To reduce the extent of the existing 40mph speed limit on A417 Gloucester Road to align with the new proposed north-western extent of the 30mph speed limit as detailed in Schedule 2 below.

| Gloucester Road (A417)        | From a point approximately 336m north-west of the centreline of its junction with Corsend Road (C69) to a point approximately 910m north-west of its junction with Corsend Road (C69). |

The length of road falls within the Parish of Hartpury in the Forest of Dean District within the County of Gloucestershire.
