

**GLOUCESTERSHIRE COUNTY COUNCIL**  
**(ONE WAY) (VARIOUS ROADS, CHELTENHAM TRANSPORT PLAN PHASE 4)**  
**EXPERIMENTAL ORDER 2018**

The Gloucestershire County Council ("the Council") in exercise of its powers under Sections 1, 2, 4, 9 and 10 of the Road Traffic Regulation Act 1984 ("the Act") and Part II and IV of Schedule 9 of the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of that Schedule hereby make the following Experimental Order:-

1. (i) This Experimental Order shall come into operation on the 28<sup>th</sup> June 2018 and may be cited as the "Gloucestershire County Council (One Way) (Various Roads, Cheltenham Transport Plan Phase 4) Experimental Order 2018" ("the Experimental Order").  
  
(ii) The roads fall within the Lansdown & Park Ward within the Borough of Cheltenham in the County of Gloucestershire.
2. In this Experimental Order:  
  
"Motor Vehicle" means a mechanically propelled vehicle intended or adapted for use on the roads as defined in Section 185 of the Road Traffic Act 1988  
"Vehicle" means a Motor Vehicle or any other vehicle unless specifically exempted by the provisions of this Experimental Order
3. No person shall cause or permit any Vehicle to proceed along those lengths of roads ("the Roads") described in the Schedule to this Experimental Order except with the permission of a Police Officer in uniform in any direction other than the way specified
4. Under Section 10(2) of the Road Traffic Regulation Act 1984, the Council may modify or suspend the operation of the Experimental Order or any provision of it if it appears essential (a) in the interest of the expeditious, convenient and safe movement of traffic (b) in the interest of providing suitable and adequate on-street parking facilities or (c) for preserving or improving the amenities of the area through which any road affected by the Experimental Order runs. This power shall be exercised only after consulting the appropriate Chief Officer of Police and giving such public notice as the Secretary of State may direct
5. The Experimental Order is Experimental and may continue in force for a period of 18 months up to 28<sup>th</sup> December 2019. In due course the Council will consider whether or not the provisions of the Experimental Order should continue in force indefinitely.
