ON STREET PARKING ORDER 2017 (DIAMOND ROAD & PLATINUM DRIVE) (ASHCHURCH RURAL PARISH) (TEWKESBURY BOROUGH) (VARIATION) ORDER 2025

NOTICE is hereby given that Gloucestershire County Council intend to make a Variation Order under Sections 1, 2, 3, 4 & 5 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers, the effect of which would vary the Gloucestershire County Council On Street Parking Order 2017 (the 2017 Order) by introducing the proposed waiting restrictions detailed in the Schedule below:

No Waiting at Any Time (Double Yellow Lines)

Road Name & Number	Extent
Diamond Road (702722/802317)	Along sections on both sides of its carriageway between its junctions with Field Maple Road (702759) and the A46.
Platinum Drive (802318)	Along sections on both sides of its carriageway between its junctions with Diamond Road (702722/802317) and Natton (C87).

Limited Waiting (Buses and Coaches) – 30 Minutes, No Return within 1 Hour

Road Name & Number	Extent
Platinum Drive (802318)	Along sections on both sides of its carriageway between its junctions with Diamond Road (702722/802317) and Natton (C87).

The lengths of roads fall within the Ashchurch Rural Parish within the Tewkesbury Borough in the County of Gloucestershire.
