INTRODUCTION

The Unemployment Bulletin provides a monthly update on unemployment data for Gloucestershire, the South West region and the United Kingdom. It is produced by the Strategic Needs Analysis Team in the County Council's Strategy and Challenge function. The data is sourced from the Office for National Statistics via Nomis (www.nomis.co.uk).

The claimant count measures the number of people claiming unemployment-related benefit (currently Job Seeker's allowance). The claimant rate is the number of claimants as a proportion of the working age population.


PART 1: SUMMARY

The claimant rate in Gloucestershire was 2.7% in September 2012. This was a decrease of -0.1% on the August 2012 figure. The South West rate remained the same as last month at 2.6%, while the UK rate fell to 3.8%. Gloucestershire's rate was 0.1% higher than the South West average of 2.6%, and 1.2% lower than the UK average of 3.8%.

The claimant count in Gloucestershire in September 2012 decreased by 187 people. The amount of people claiming in September 2012 was -1.8% lower than the number in August 2012. This compares to a -1.7% decrease in the South West and a -1.1% decrease for the UK.

The year on year claimant count in Gloucestershire has decreased since last month. The count was 2.6% higher in September 2012 than at the same point in the previous year as shown in the graph below.

YOUNG PEOPLE NOT IN EDUCATION, EMPLOYMENT OR TRAINING (NEET)

As at the end of September 2012 there were 616 young people aged 16-18 not in education, employment or training in Gloucestershire and this figure translates into an adjusted (*) 16-18 NEET population of 5.3%.

Figure 1: Claimant Rate for Gloucestershire, the South West and UK over the past year




Figure 1 shows the claimant rate for Gloucestershire at 2.7% in September 2012. The rate remained lower or the same as the South West average, until March when it grew above the South West rate, it has been persistently lower by approximately 1.2% against the UK average during the same period. The September 2012 rate represented a -0.1% decrease on August 2012..

Table 1 shows that in September 2012, the number of claimants in Gloucestershire was -1.8% lower than the number in August 2012.

The average change in claimants in Gloucestershire for the six months to September 2012 was -0.9%. This is 0.2% higher than the UK average and 0.4% lower than the South West average.

Figure 2: Claimant Rate (%) across Gloucestershire - September 2012




Figure 2 shows the claimant rate for September 2012 in Gloucestershire. Between August 2012 and September 2012 the rate in the Cotswold, Gloucester and Tewkesbury declined, the rate in the other districts remained the same.

Figure 3: Total claimants over the past year across Gloucestershire Districts




Figure 3 shows the overall claimant count by district over the past year. The number of claimants generally increased between September 2011 and February 2012. Since March 2012 the number of claimants has decreased, with the exception of September 2012, when they increased.

Figure 4: Cheltenham Borough claimant rate over the last year




Figure 4 shows the claimant rate in Cheltenham remained the same as last month at 3.2%.

Figure 5: Cheltenham Borough claimants - Month on Month and Year on Year change




Figure 5 shows the claimant count decreased by -0.1% since last month. The change on the previous year has decreased in September 2012 compared to August 2012 to +5.5%.

Figure 6: Claimant rates across Cheltenham Borough wards - September 2012







Figure 8: Cotswold District claimants - Month on Month and Year on Year change

Figure 9: Claimant rates across Cotswold District wards - September 2012



Figure 10: Forest of Dean District claimant rate over the last year



Figure 11: Forest of Dean District claimants - Month on Month and Year on Year change



Figure 12: Claimant rates across Forest of Dean District wards - September 2012







Figure 14: Gloucester City claimants - Month on Month and Year on Year change

Figure 15: Claimant rates across Gloucester City wards - September 2012







Figure 17: Stroud District claimants - Month on Month and Year on Year change

Figure 18: Claimant rates across Stroud District wards - September 2012







Figure 20: Tewkesbury District claimants - Month on Month and Year on Year change

Figure 21: Claimant rates across Tewkesbury District wards - September 2012









PART 6: YOUNG PEOPLE NOT IN EDUCATION, EMPLOYMENT OR TRAINING (NEET) IN GLOUCESTERSHIRE

Data provided by Prospects, the Connexions service in Gloucestershire on the situation of young people (16-18) in Gloucestershire who are not in education, employment or formal training.

Connexions Gloucestershire is required to report performance with the 16-18 age range against nationally defined criteria for counting the NEET group. The NEET group includes young people actively seeking education, employment or training as well as those young people who are either not yet ready or who are unable to access these opportunities because of their personal circumstances. The figures quoted below include young people in both of these categories.

Summary

As at the end of September 2012 there were 616 young people aged 16-18 not in education, employment or training in Gloucestershire and this figure translates into an adjusted (*) 16-18 NEET population of 5.3%. The total number of NEET decreased by 27 young people in September 2012 compared to August 2012. 1 district saw an increase and 5 saw a decrease in their NEET figure.
