Notice is given in accordance with the above Regulations that Gloucestershire County Council on the 5th September 2011 submitted the Gloucestershire Waste Core Strategy (WCS) to the Secretary of State for Communities and Local Government.

The Waste Core Strategy provides a planning framework for waste management across the county of Gloucestershire in the period 2012 – 2027. It identifies a number of key issues relevant to Gloucestershire and translates these into a vision, objectives and strategy. When adopted, the Waste Core Strategy will form part of the Gloucestershire Minerals and Waste Development Framework.
