

Due Regard for Permanent TROs

The Council has a duty to give 'due regard to' the following three aims of the public sector equality duty (section 149 of the Equality Act 2010) during the development of the 'policy'.¹

- Eliminate discrimination, harassment and victimisation and any other conduct prohibited by the ACT;
- Advance equality of opportunity between people who share a protected characteristic and people who do not share it; and
- Foster good relations between people who share a protected characteristic

Scheme name	No Entry, One Way, Waiting/Loading and Bus Lane restrictions – The Forum, Station Road and Surrounding area, Gloucester

Age(A)	The no entry and one way restrictions will make it safer for all age groups visiting the Forum by limiting the amount of traffic in the vicinity
Disability (D)	The no entry and one way restrictions will make it safer for all disability groups visiting the Forum by limiting the amount of traffic in the vicinity. The loading bans will prevent blue badge holders from parking, however, there will be designated disabled bays within the Forum Car Park.
