INTRODUCTION

The Unemployment Bulletin provides a monthly update on unemployment data for Gloucestershire, the South West region and the United Kingdom. It is produced by the Strategic Needs Analysis Team in the County Council's Strategy and Challenge function. The data is sourced from the Office for National Statistics via Nomis (www.nomis.co.uk).

The claimant count measures the number of people claiming unemployment-related benefit (currently Job Seeker's allowance). The claimant rate is the number of claimants as a proportion of the working age population.

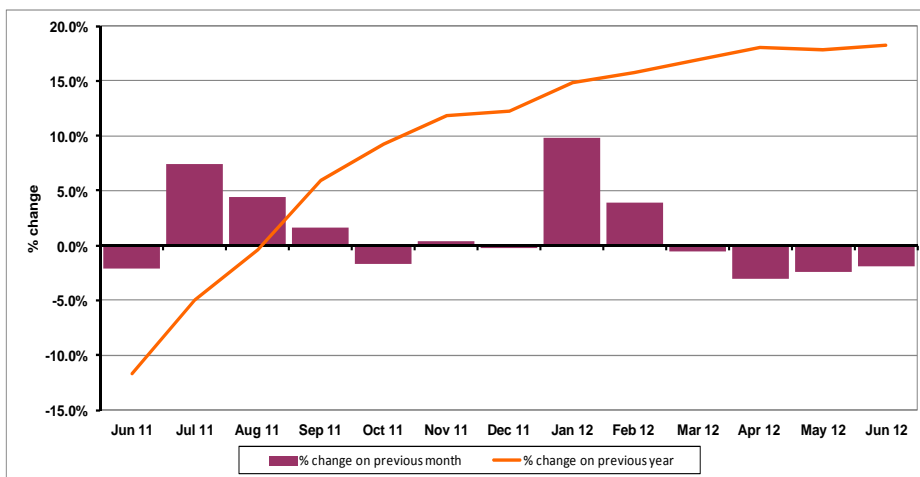
PART 1: SUMMARY

The claimant rate in Gloucestershire was 2.7% in June 2012. This was a decrease of 0.1% on the May 2012 figure. The South West rate decreased to 2.6% while the UK rate remained the same as last month at 3.9%. Gloucestershire's rate was 0.1% higher than the South West average of 2.6%, and 1.2% lower than the UK average of 3.9%.

The claimant count in Gloucestershire in June 2012 decreased by 192 people. The amount of people claiming in June 2012 was -1.8% lower than the number in May 2012. This compares to a -3.2% decrease in the South West and a -1.7% decrease for the UK.

The year on year claimant count in Gloucestershire has increased. The count was 18.2% higher in June 2012 than at the same point in the previous year as shown in the graph below.

YOUNG PEOPLE NOT IN EDUCATION, EMPLOYMENT OR TRAINING (NEET)

As at the end of June 2012 there were 635 young people aged 16-18 not in education, employment or training in Gloucestershire and this figure translates into an adjusted (*) 16-18 NEET population of 4.9%.

Figure 1: Claimant Rate for Gloucestershire, the South West and UK over the past year

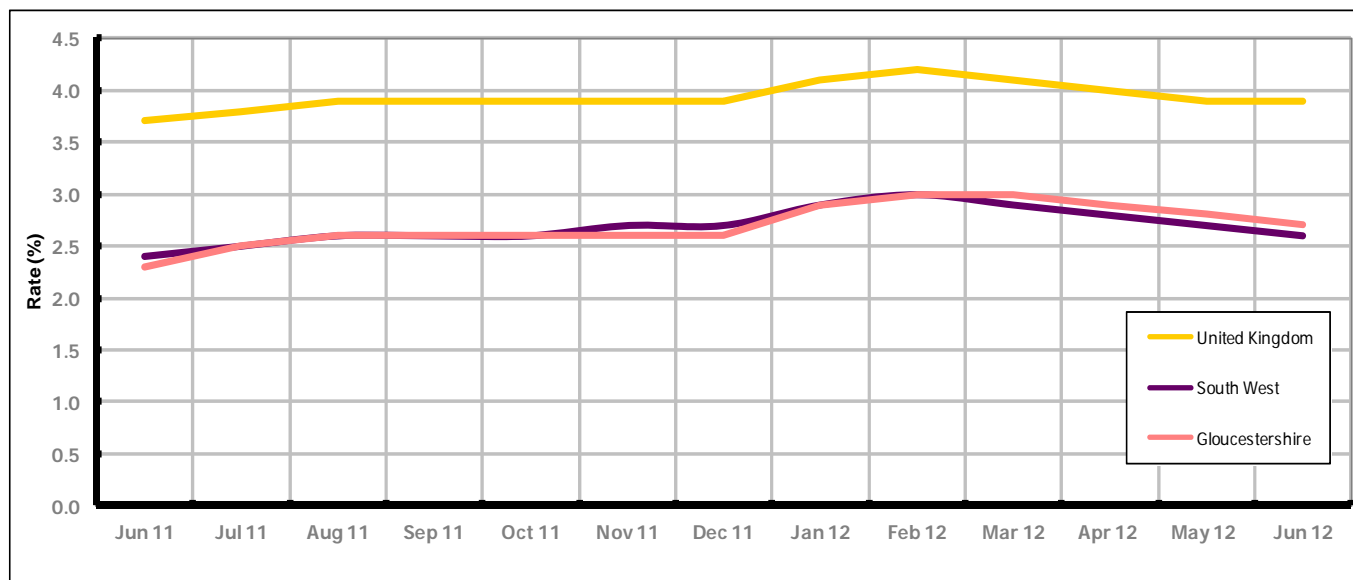


Figure 1 shows the claimant rate for Gloucestershire at 2.7% in June 2012. The rate remained lower or the same as the South West average, until March 2012, when it grew above the South West rate, it has been persistently lower by approximately 1.2% against the UK average during the same period. The June 2012 rate represented a 0.1% decrease on May 2012.

Table 1 shows that in June 2012, the number of claimants in Gloucestershire was -1.8% lower than the number in May 2012.

The average change in claimants in Gloucestershire for the six months to June 2012 was -0.7%. This is 0.2% higher than the UK average and 1.0% higher than the South West average.

Figure 2: Claimant Rate (%) across Gloucestershire - June 2012

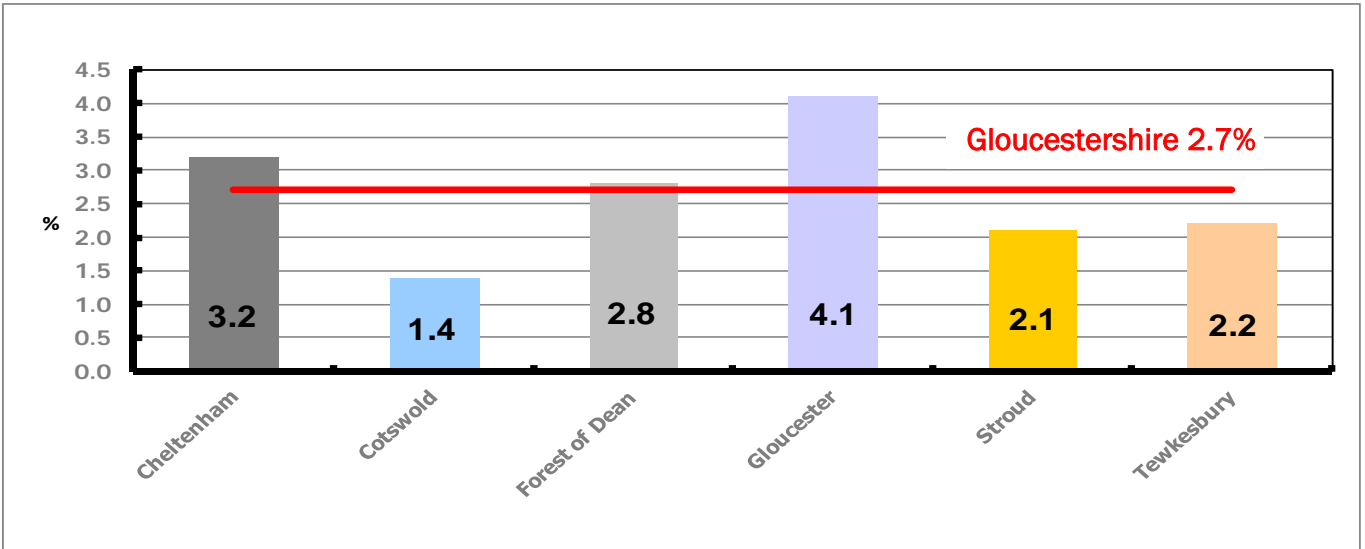

Figure 3: Total claimants over the past year across Gloucestershire Districts

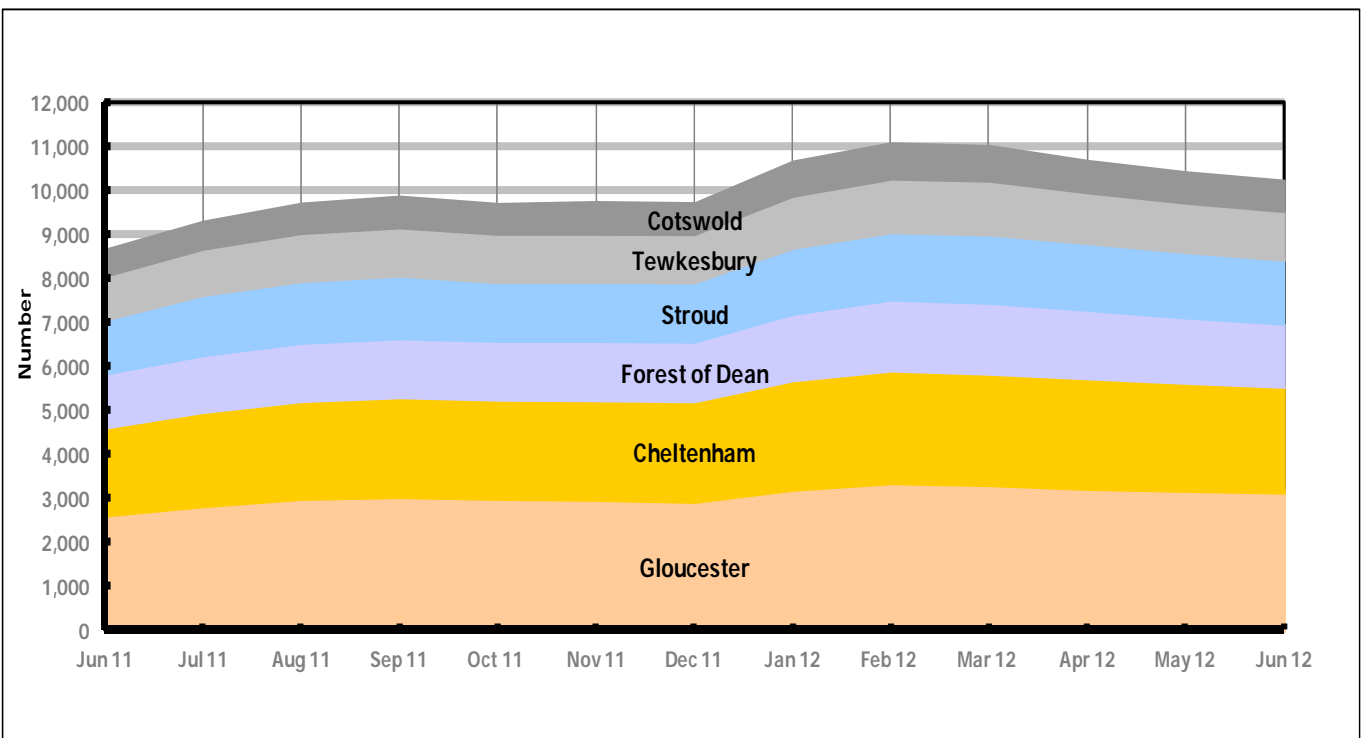

Figure 4: Cheltenham Borough claimant rate over the last year

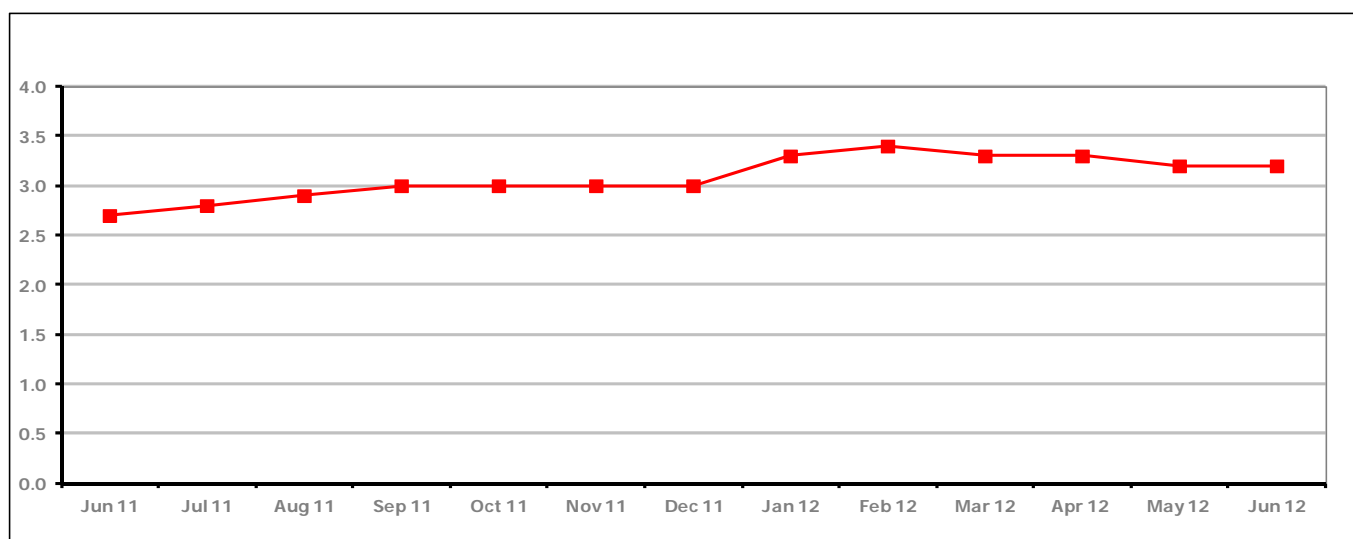


Figure 4 shows the claimant rate in Cheltenham remained the same as last month at 3.2%.

Figure 5: Cheltenham Borough claimants - Month on Month and Year on Year change

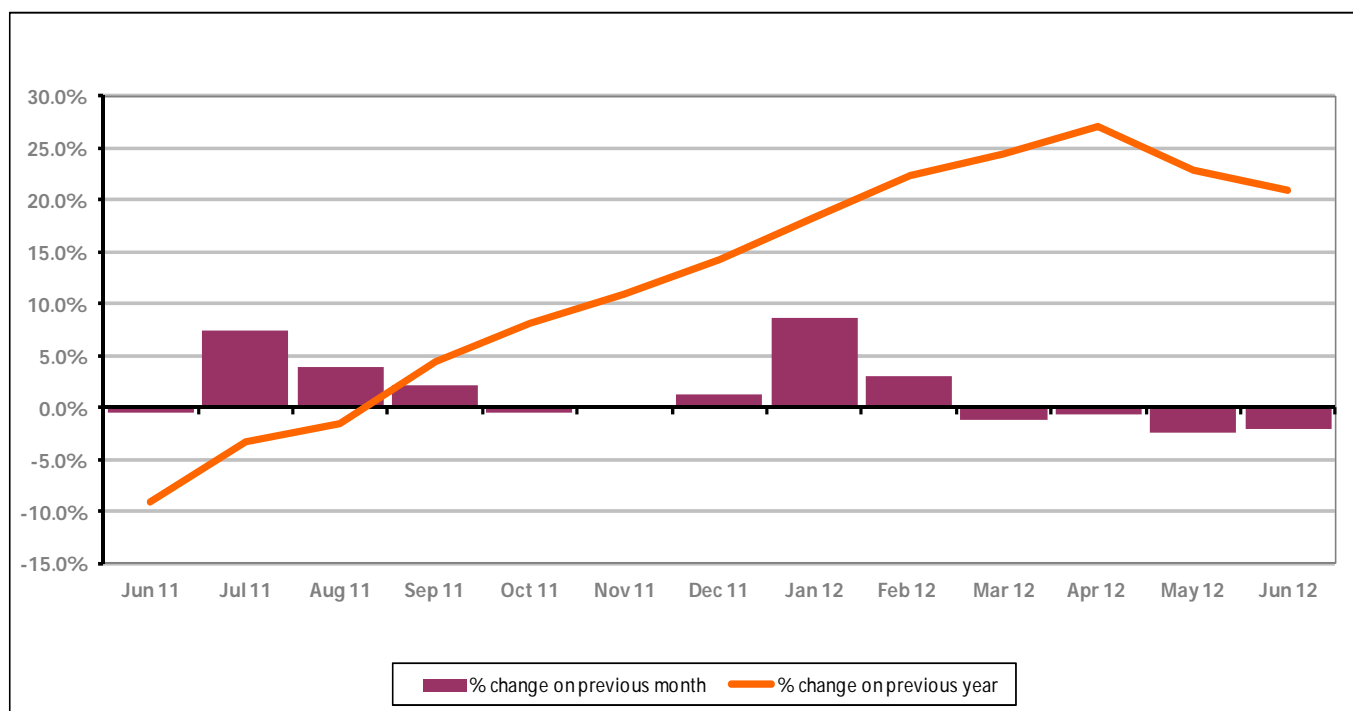


Figure 5 shows the claimant count decreased by -2.1% since last month. The change on the previous year has decreased in June 2012 compared to May 2012 to +20.9%.

Figure 6: Claimant rates across Cheltenham Borough wards - June 2012

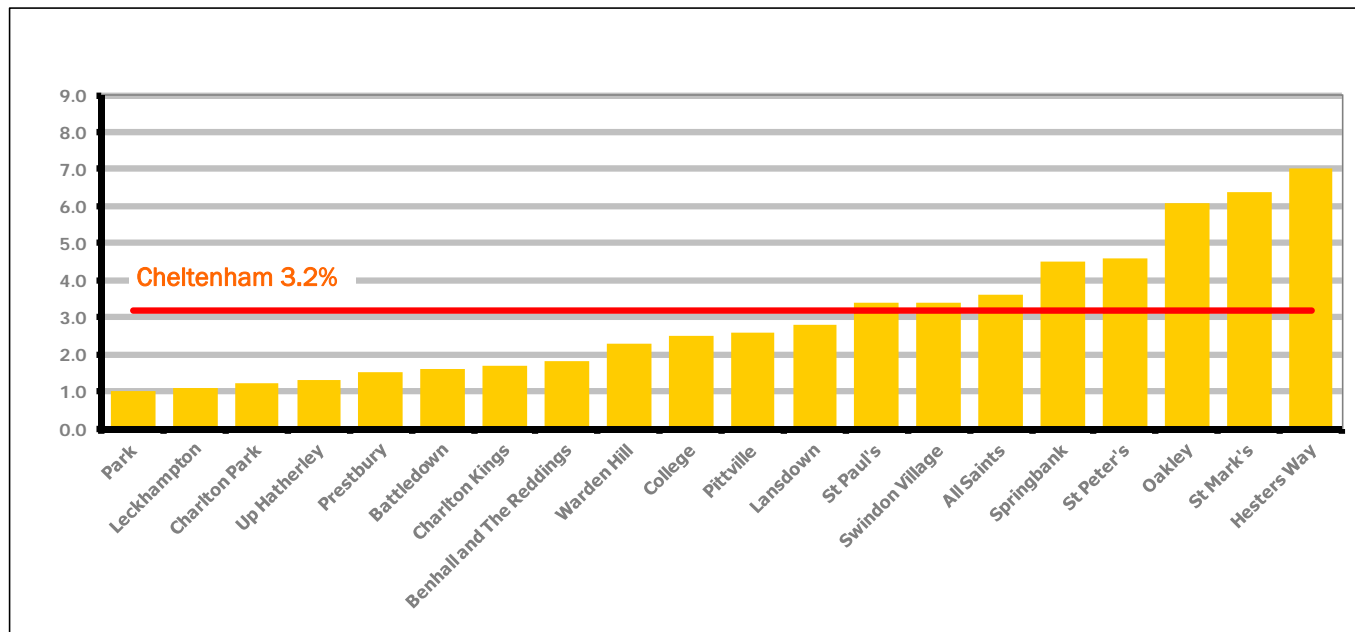
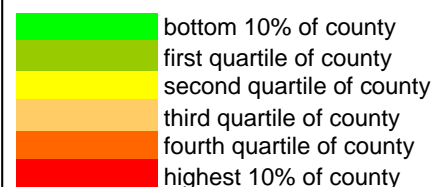

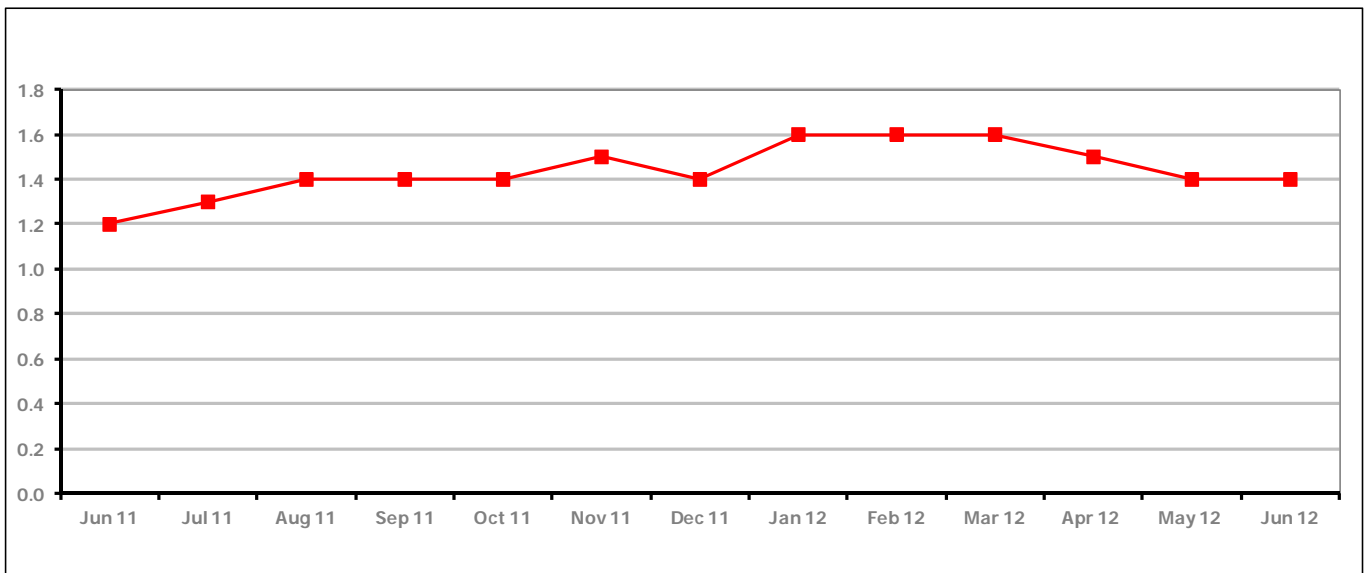

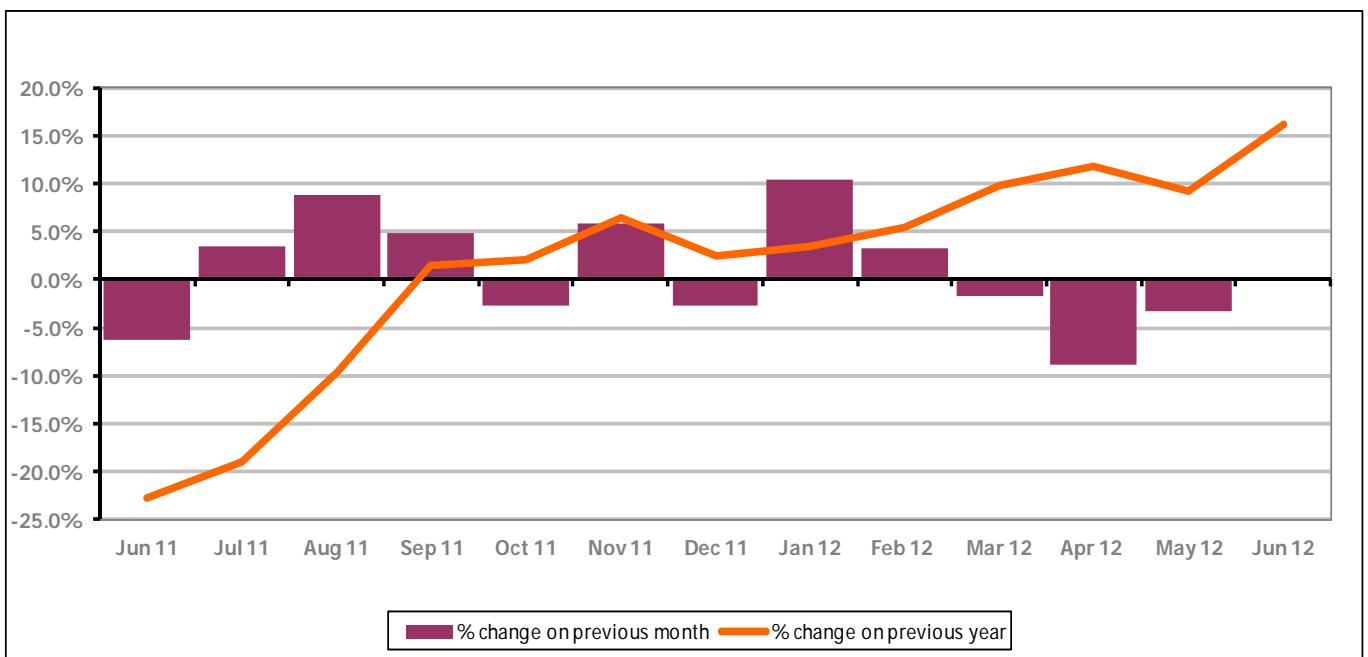
Figure 8: Cotswold District claimants - Month on Month and Year on Year change

Figure 9: Claimant rates across Cotswold District wards - June 2012

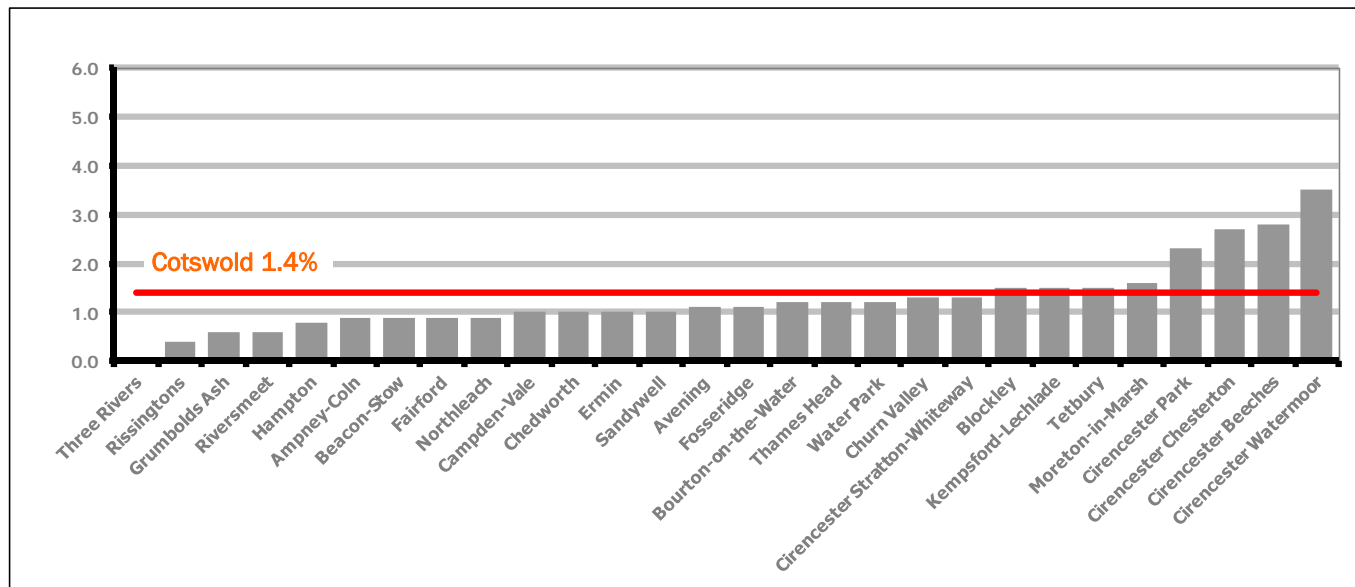
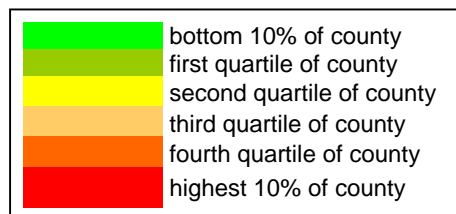


Figure 9 shows the claimant rates for Cotswold District wards. The red line represents the average claimant rate across the District of 1.4%. Eight wards lie above the average.

Figure 10: Forest of Dean District claimant rate over the last year

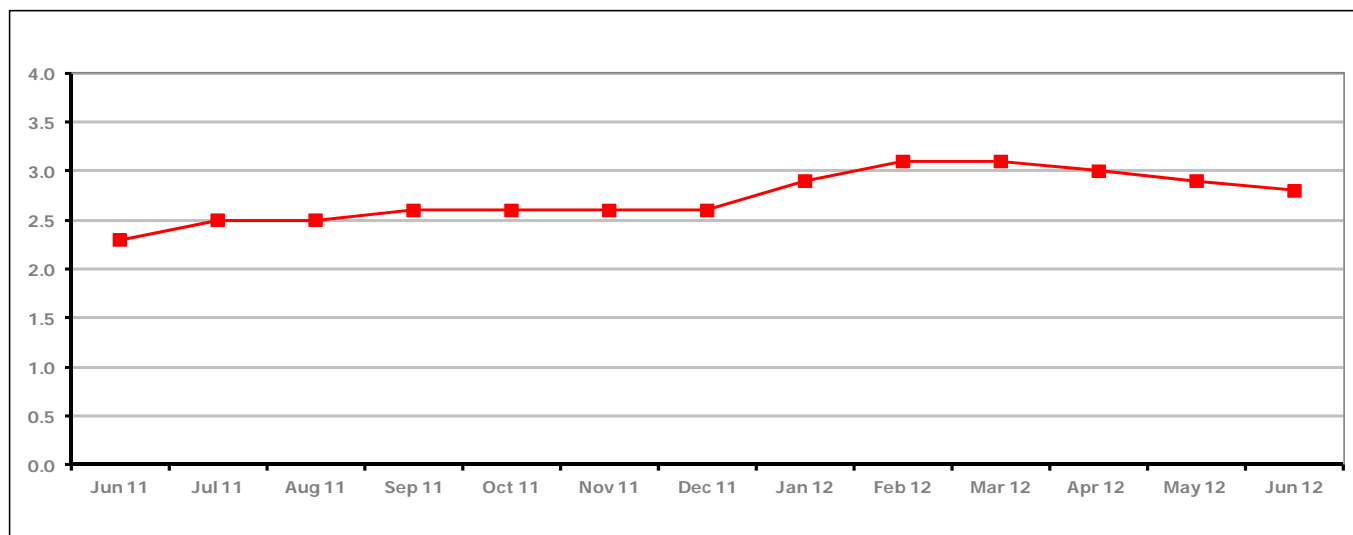

Figure 11: Forest of Dean District claimants - Month on Month and Year on Year change

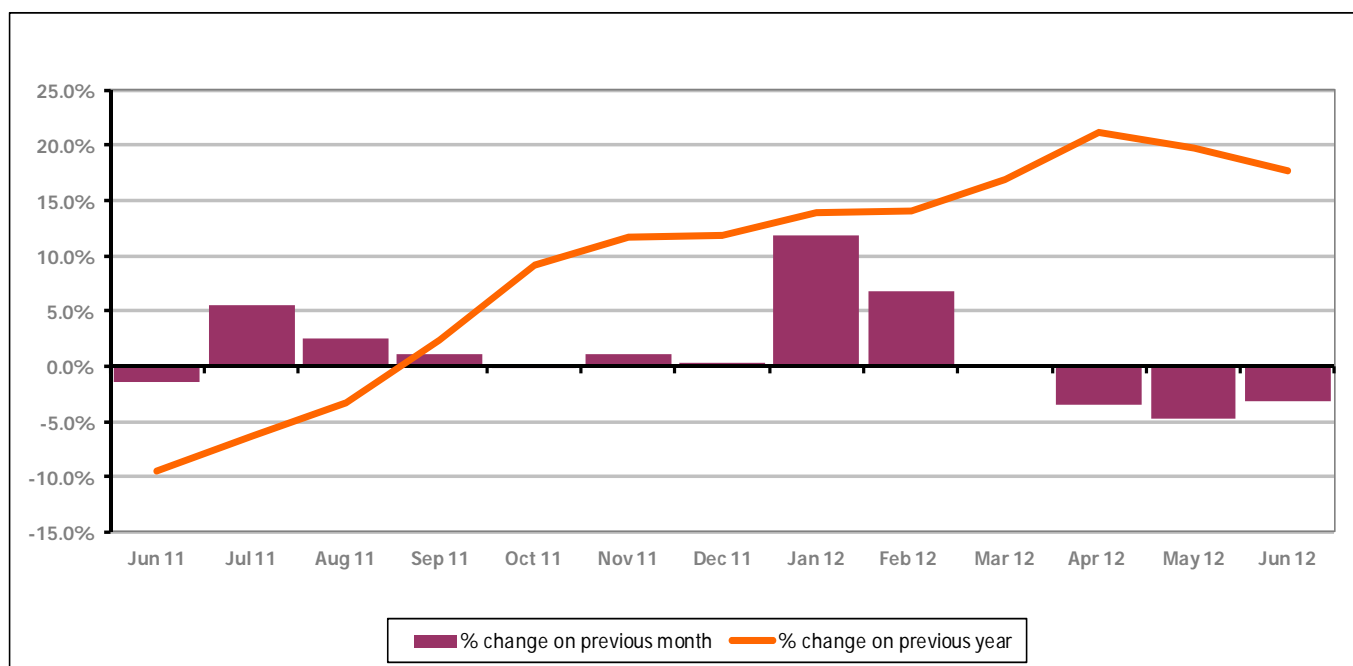

Figure 12: Claimant rates across Forest of Dean District wards - June 2012

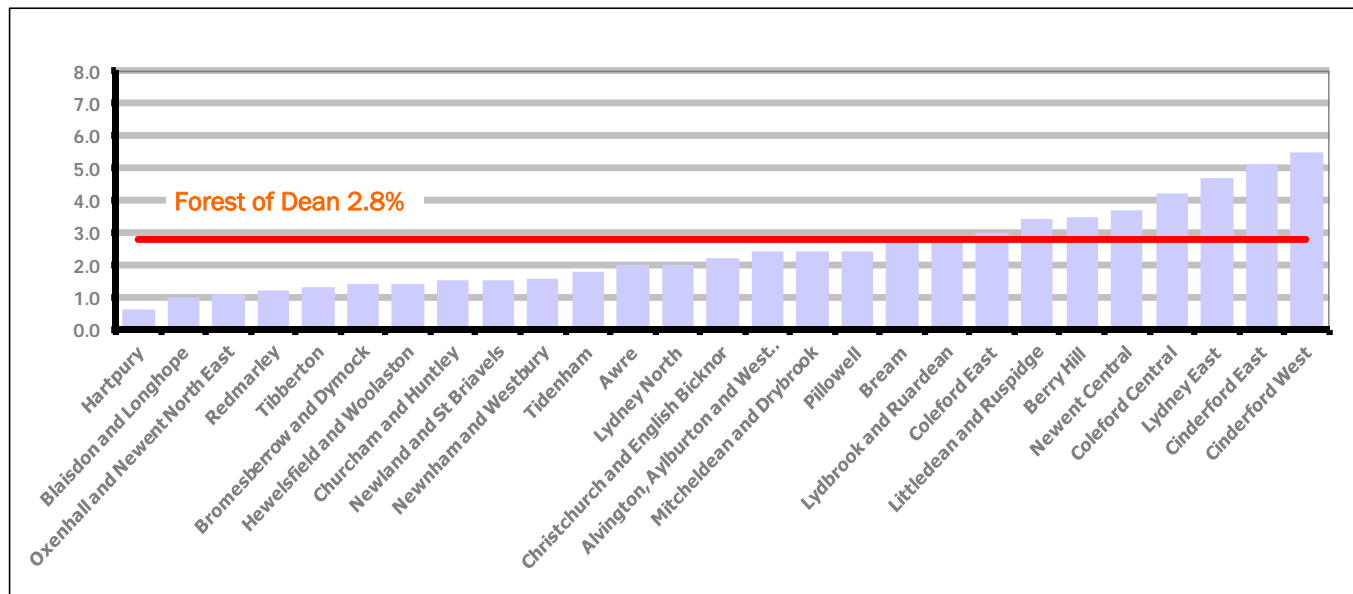
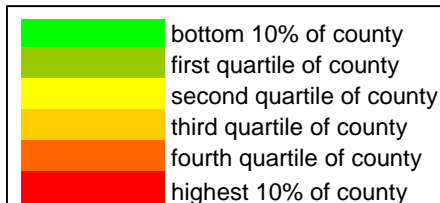

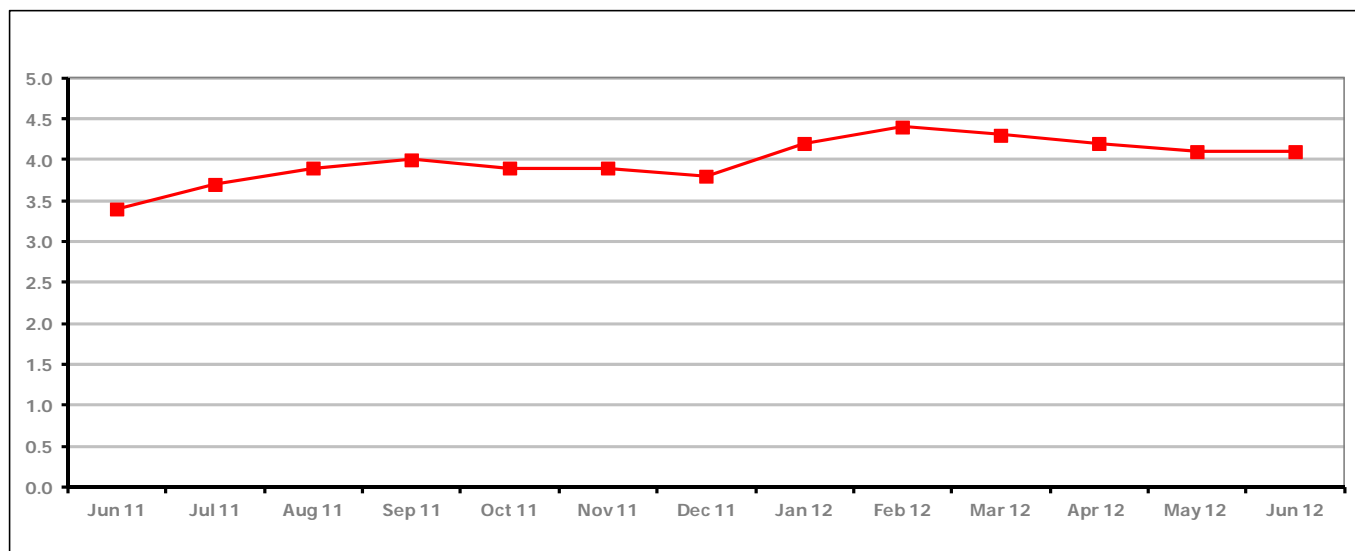

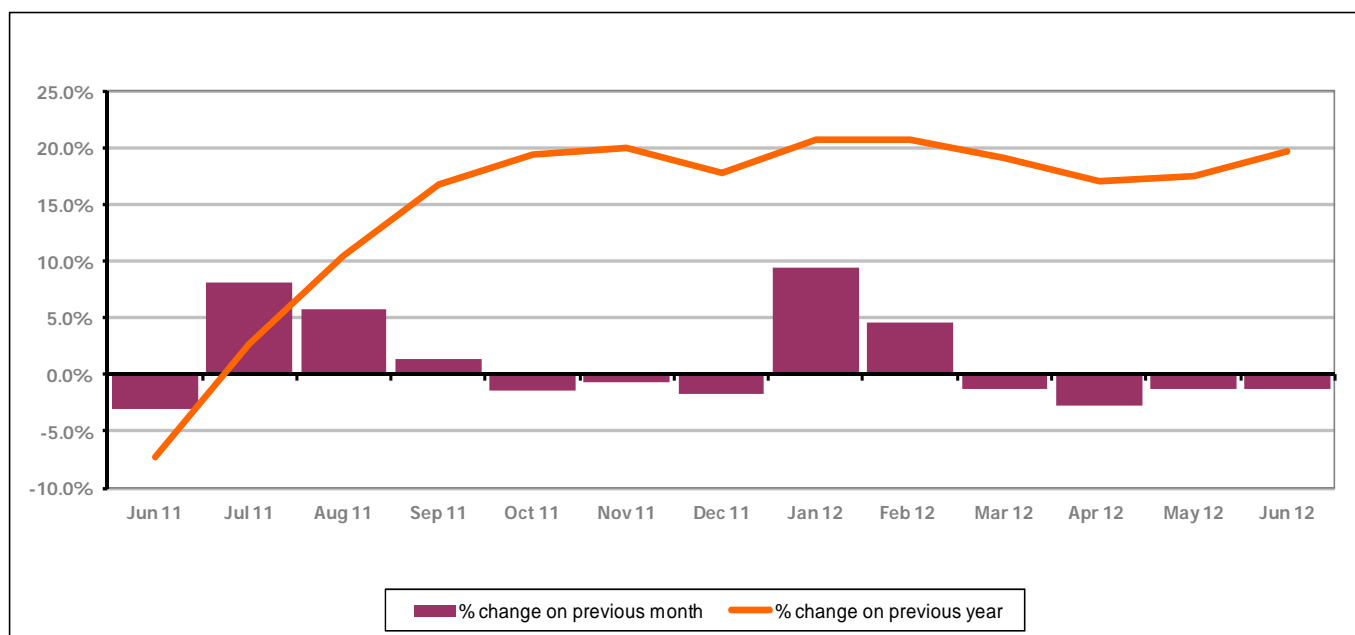
Figure 14: Gloucester City claimants - Month on Month and Year on Year change

Figure 15: Claimant rates across Gloucester City wards - June 2012

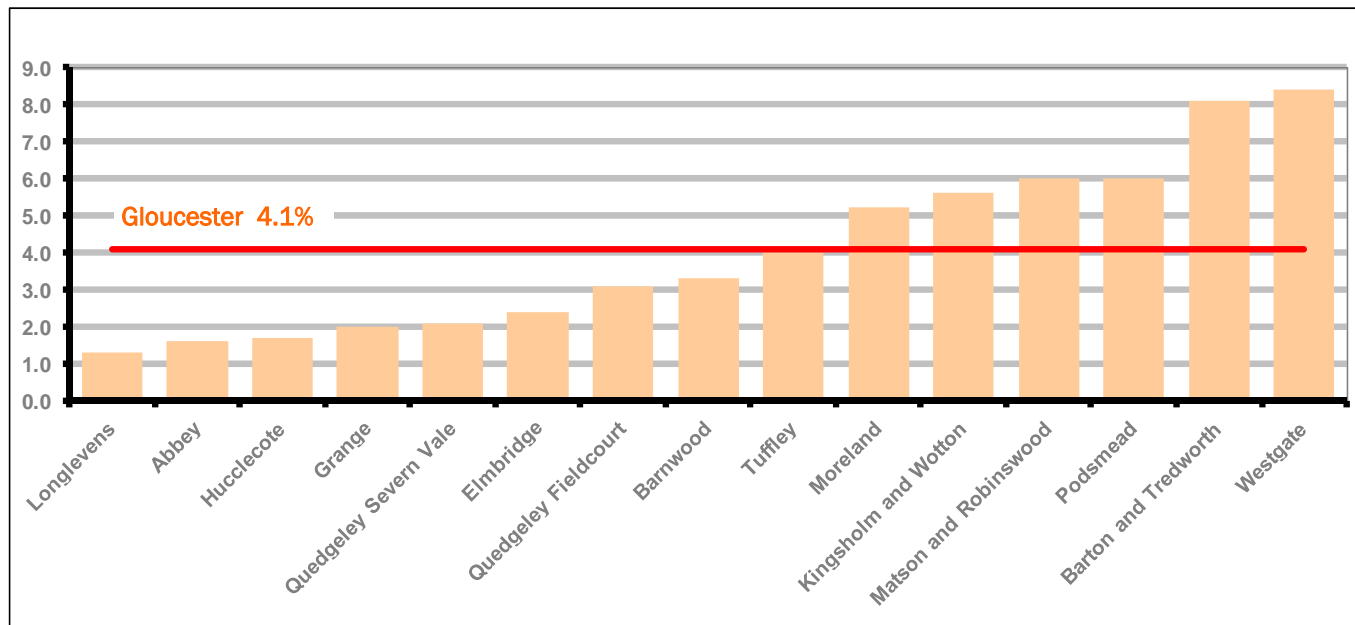
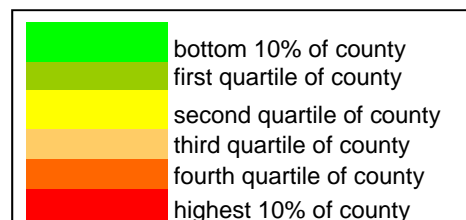


Figure 15 shows the claimant rates for Gloucester City district wards. The red line represents the average claimant rate across the City of 4.1%. Six wards lie above the average.

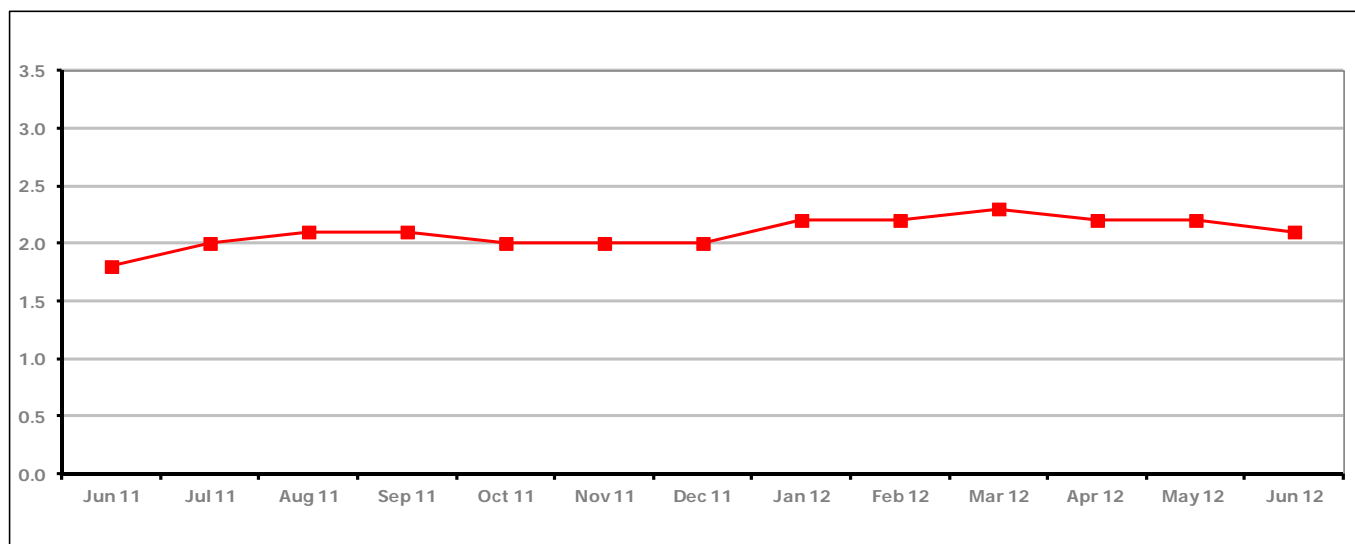

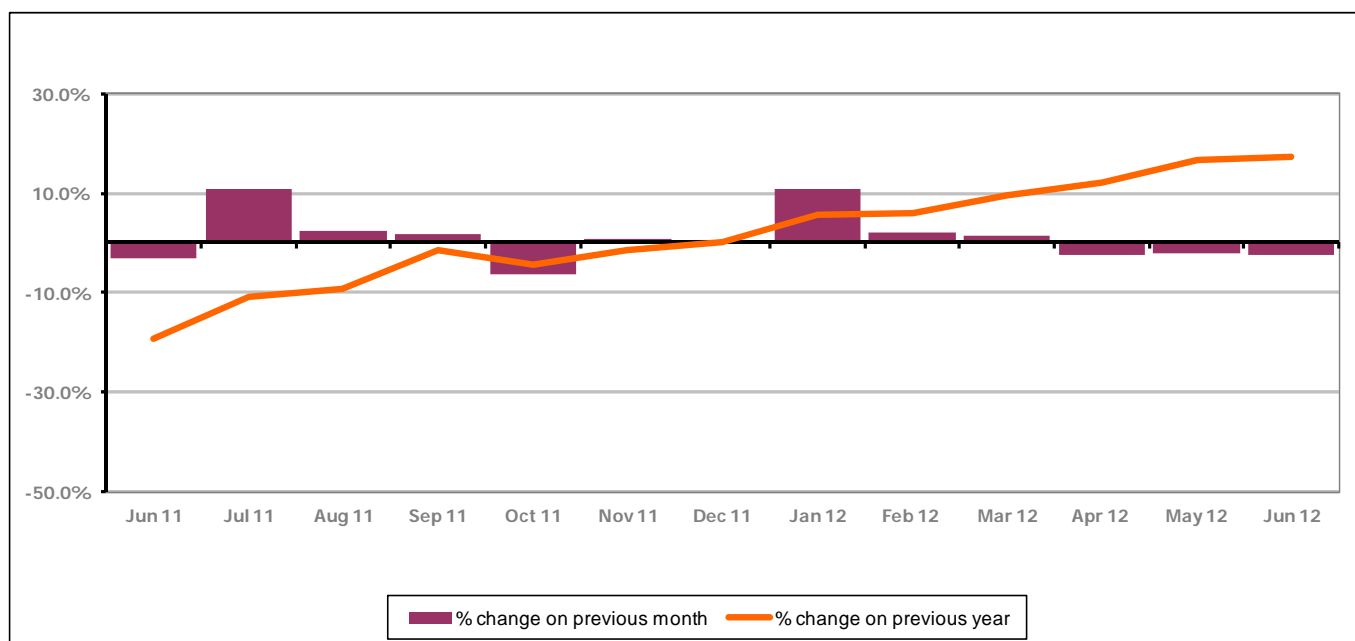
Figure 17: Stroud District claimants - Month on Month and Year on Year change

Figure 18: Claimant rates across Stroud District wards - June 2012

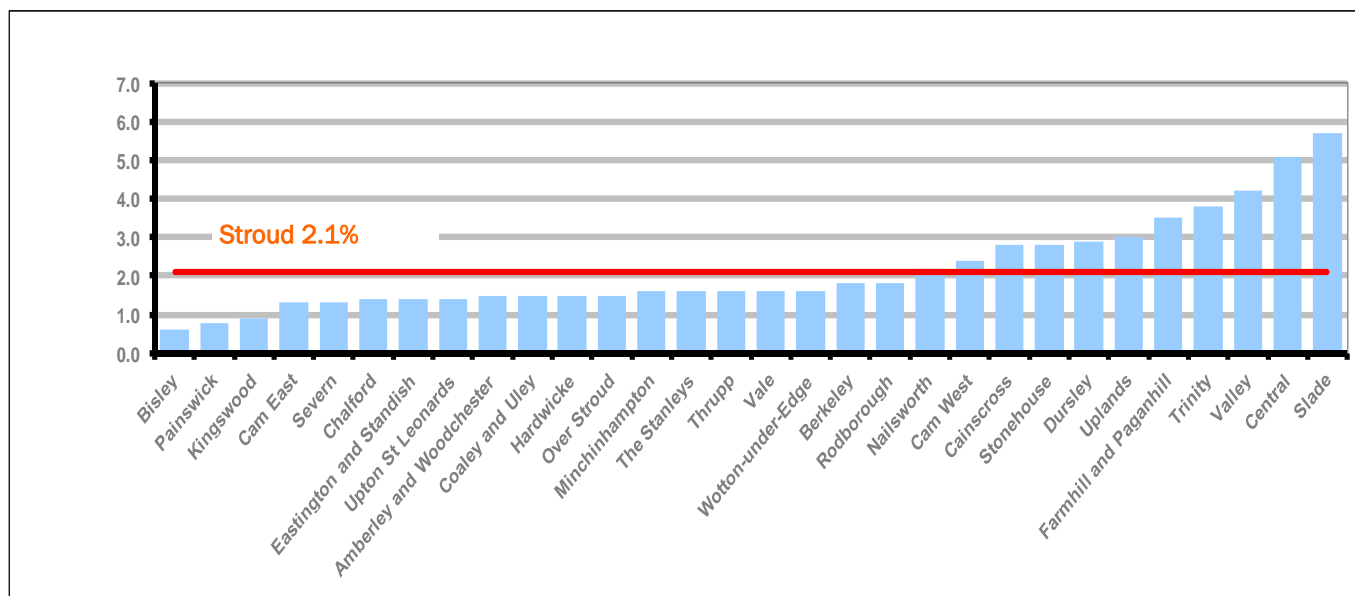
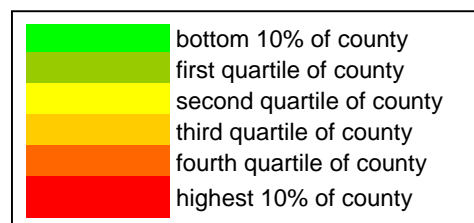

Figure 19: Tewkesbury District claimant rate over the last year

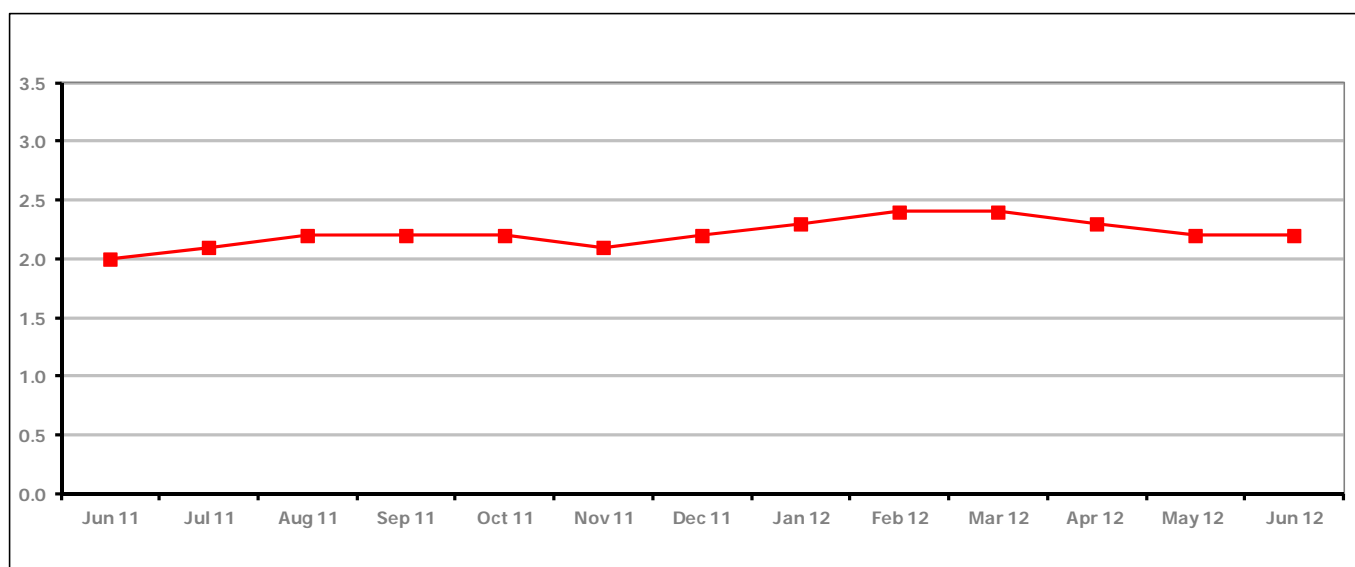

Figure 20: Tewkesbury District claimants - Month on Month and Year on Year change

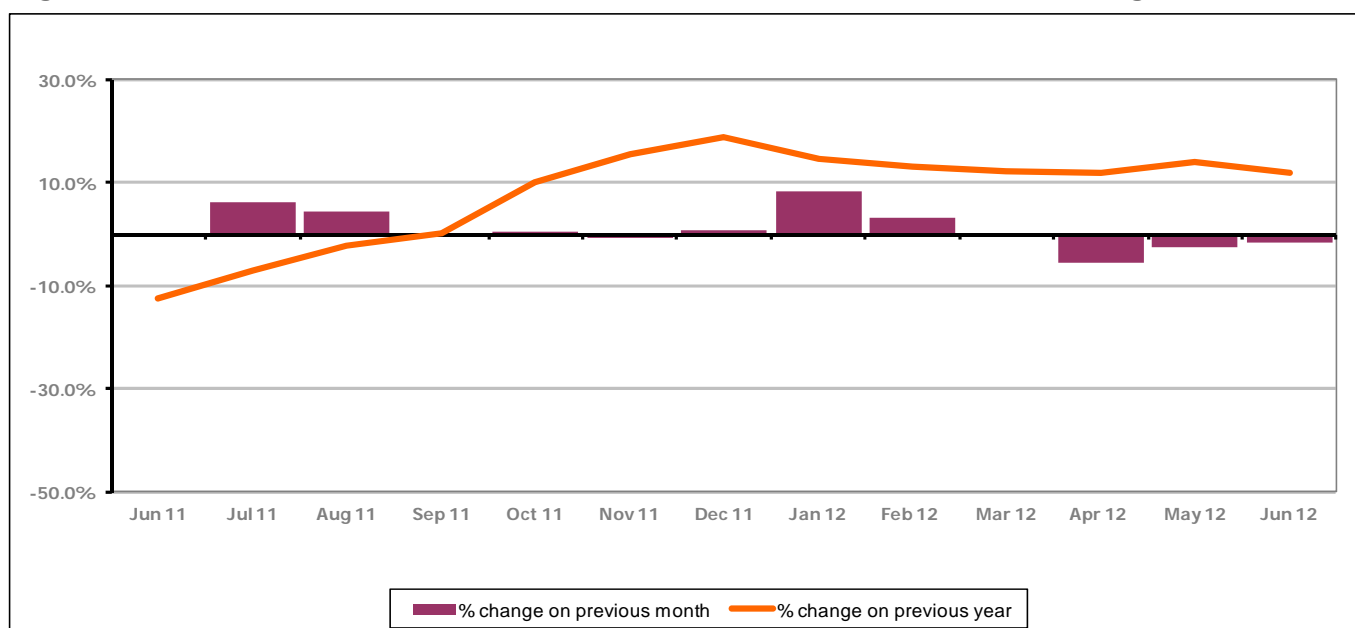

Figure 21: Claimant rates across Tewkesbury District wards - June 2012

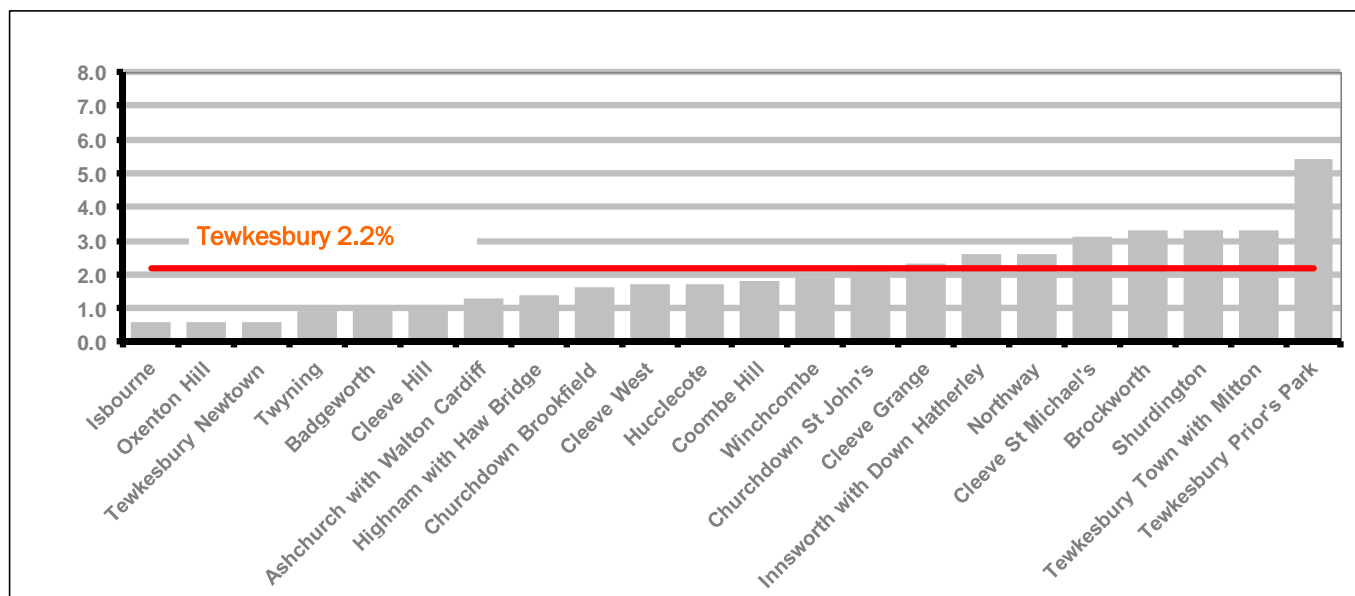
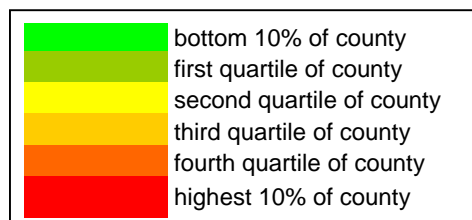

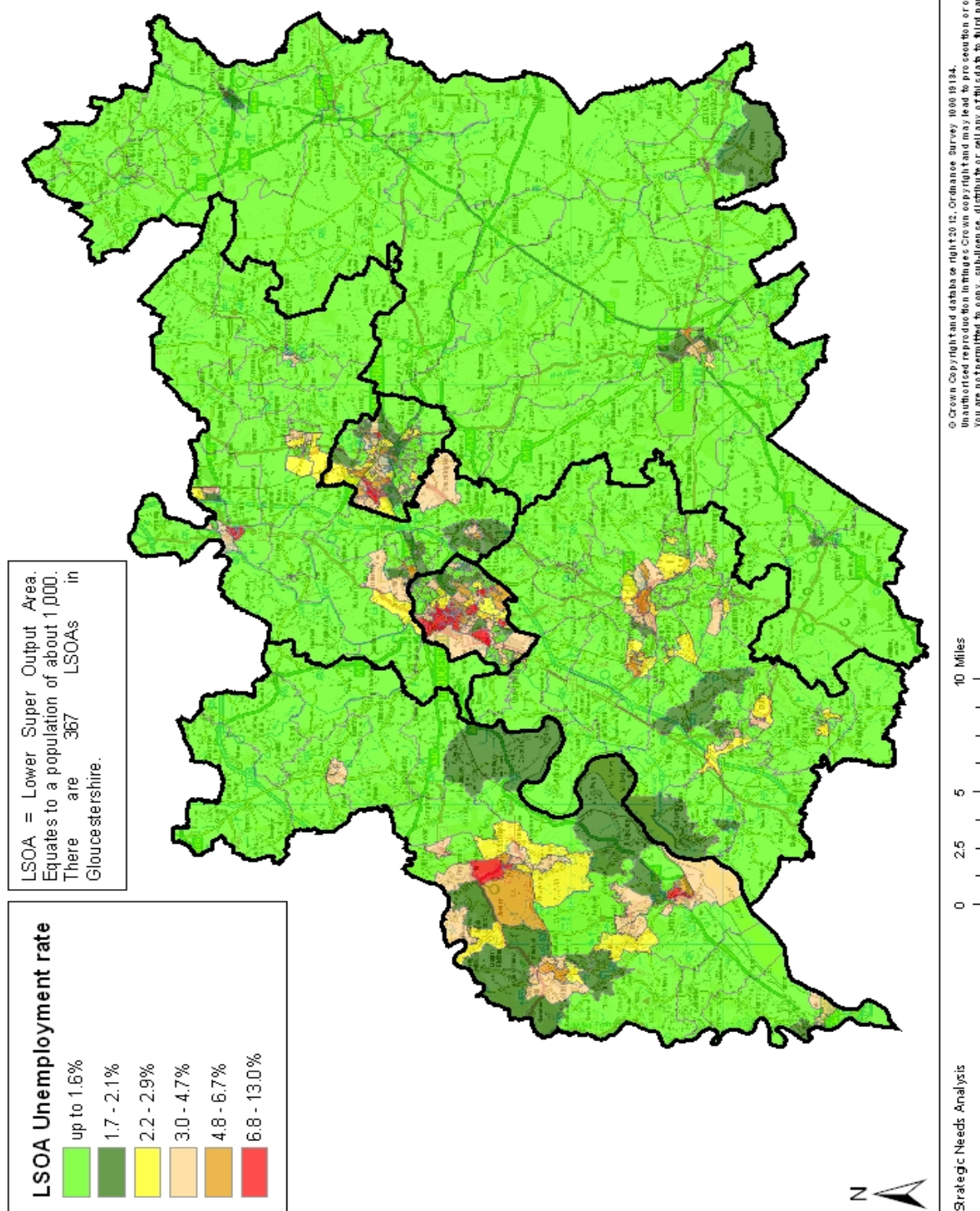

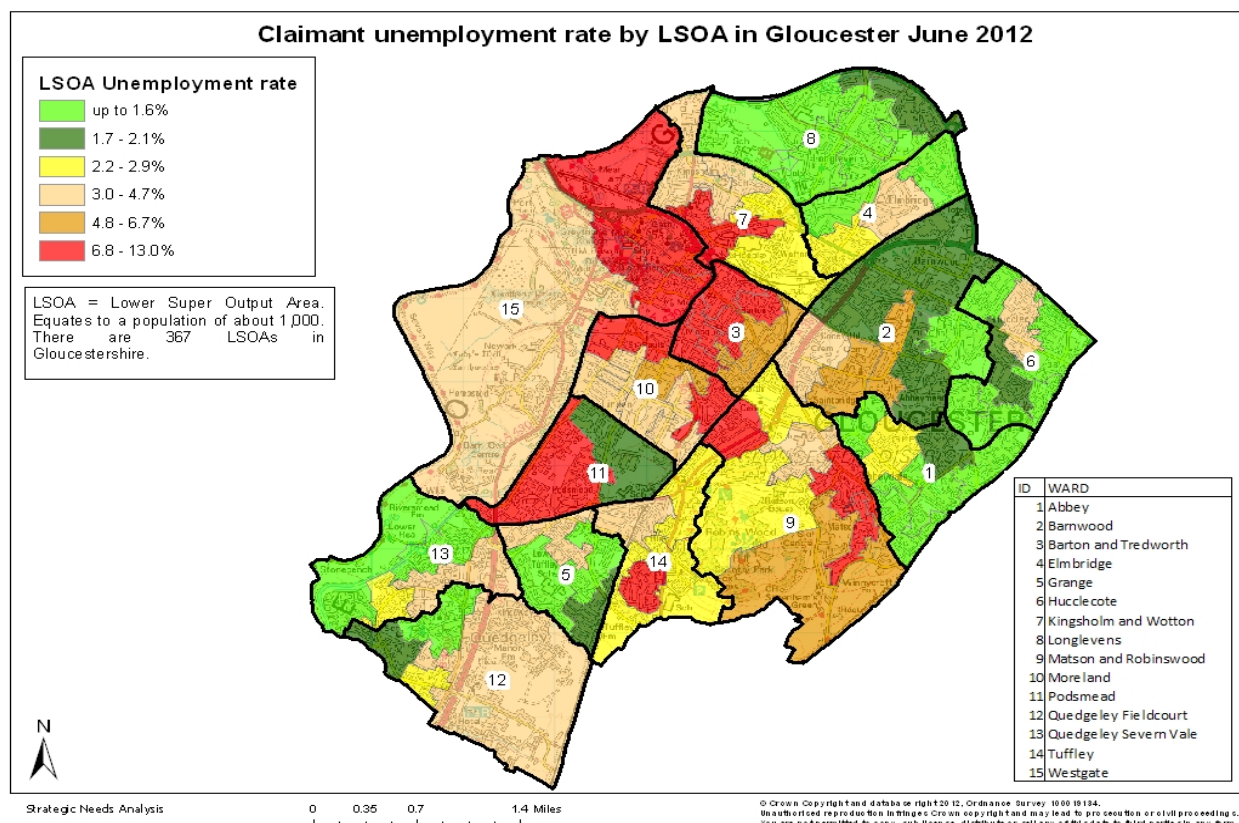
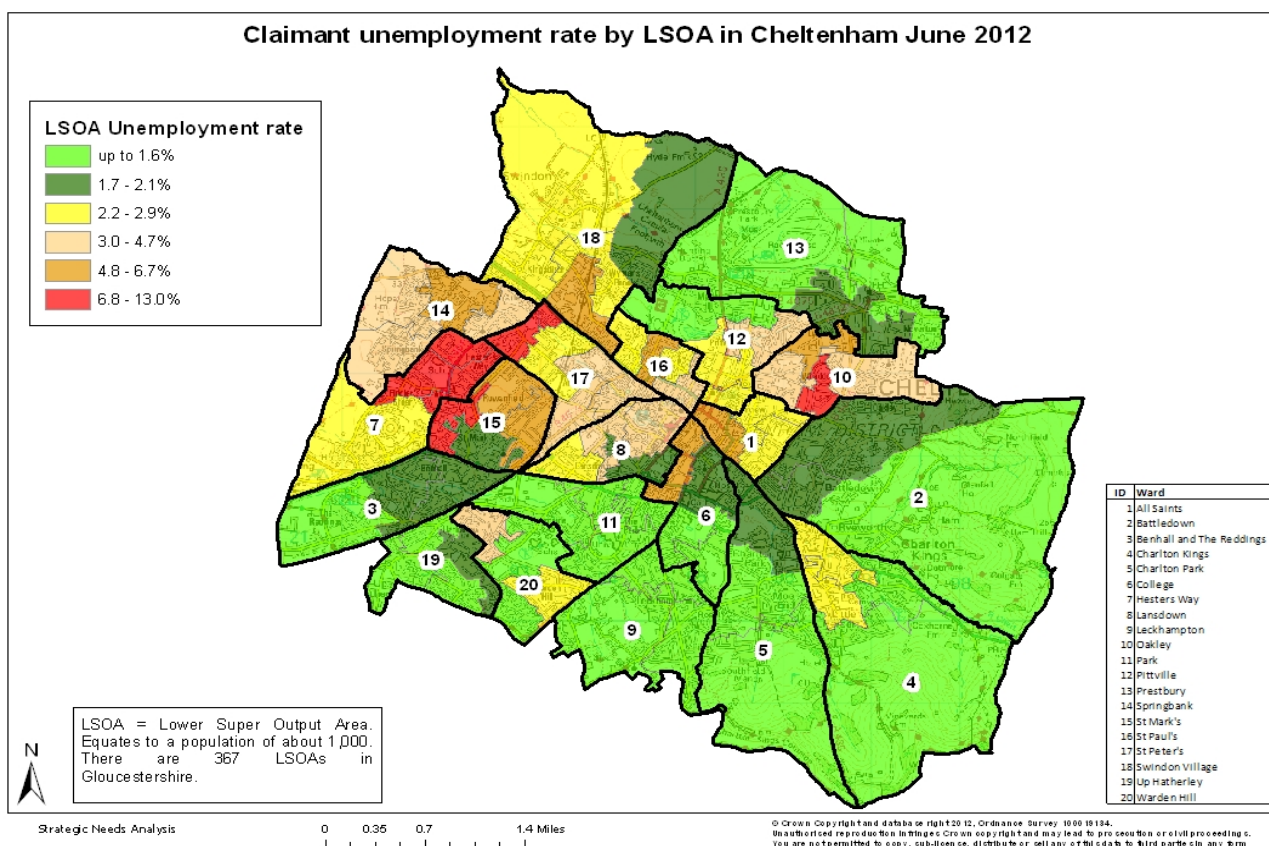

PART 6: YOUNG PEOPLE NOT IN EDUCATION, EMPLOYMENT OR TRAINING (NEET) IN GLOUCESTERSHIRE

Data provided by Prospects, the Connexions service in Gloucestershire on the situation of young people (16-18) in Gloucestershire who are not in education, employment or formal training.

Connexions Gloucestershire is required to report performance with the 16-18 age range against nationally defined criteria for counting the NEET group. The NEET group includes young people actively seeking education, employment or training as well as those young people who are either not yet ready or who are unable to access these opportunities because of their personal circumstances. The figures quoted below include young people in both of these categories.

Summary

As at the end of June 2012 there were 635 young people aged 16-18 not in education, employment or training in Gloucestershire and this figure translates into an adjusted (*) 16-18 NEET population of 4.9%. The total number of NEET increased by 11 young people in June 2012 compared to May 2012. 3 districts saw an increase and 2 saw a decrease in their NEET figure. 1 District stayed the same.
