

GLOUCESTERSHIRE COUNTY COUNCIL
ON-STREET PARKING ORDER 2017
(VARIOUS ROADS, CHELTENHAM TRANSPORT PLAN PHASE 4) (EXPERIMENTAL
VARIATION) (AMENDMENT NO. 1) ORDER 2019

Gloucestershire County Council in exercise of its powers under sections 1, 2, 4, 9, 10, 32, 35, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the 1984 Act) and the Traffic Management Act 2004 (the 2004 Act) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Experimental Variation Amendment No. 1 Order.

1. The Gloucestershire County Council On-Street Parking Order 2017 ("the 2017 Order") shall be amended by the revocation of the existing sealed plans specified in the First Schedule to this Experimental Variation Amendment No. 1 Order and which are hereby replaced with the new sealed plans specified in the Second Schedule to this Experimental Variation Amendment No. 1 Order.
2. The effect of this Experimental Variation Amendment no. 1 Order is to experimentally introduce the restrictions set out in the Third Schedule to this Experimental Variation Amendment No. 1 Order which will experimentally replace any current restrictions on those specific lengths of roads.

3. The remainder of the 2017 Order shall remain in full force and effect including any restrictions that have not been experimentally replaced by this Experimental Variation Amendment No. 1 Order
4. Under Section 10(2) of the Road Traffic Regulation Act 1984, Gloucestershire County Council may modify or suspend the operation of the Experimental Variation Amendment No. 1 Order or any provision of it if it appears essential (a) in the interest of the expeditious, convenient and safe movement of traffic (b) in the interest of providing suitable and adequate on-street parking facilities or (c) for preserving or improving the amenities of the area through which any road affected by the Experimental Variation Amendment No. 1 Order runs. This power shall be exercised only after consulting the appropriate Chief Officer of Police and giving such public notice as the Secretary of State may direct
5. The Experimental Variation Amendment No. 1 Order is Experimental and may continue in force for a period of 18 months from the date of the original experimental order up to 28th December 2019. In due course the Council will consider whether or not the provisions of the Experimental Variation Amendment No. 1 Order should continue in force indefinitely
6. This Experimental Variation Amendment No. 1 Order shall come into effect on the 3rd day of June 2019 and may be cited as "The Gloucestershire County Council on-Street Parking Order 2017 (Various Roads, Cheltenham Transport Plan Phase 4) (Experimental Variation) (Amendment No. 1) Order 2019"

7. In the event of any inconsistency or ambiguity between the content of this Experimental Variation Amendment No. 1 Order and any existing permanent/experimental Order(s) imposing restriction(s) on the lengths of roads described in the Schedules to this Experimental Variation Amendment No. 1 Order the latter will be suspended for the duration of the Experimental Variation Amendment No. 1 Order and the provisions of this Experimental Variation Amendment No. 1 Order shall prevail during that period.
