

**PUBLIC NOTICE**  
**GLOUCESTERSHIRE COUNTY COUNCIL**  
**ON STREET PARKING ORDER 2017 (BATH ROAD) (TOWN OF CHELTENHAM)**  
**ORDER 2024**

NOTICE is hereby given that Gloucestershire County Council intend to make a Variation Order under Sections 1, 2, 3, 4, 5 32, 35, 36, 39, 45 & 46 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers, the effect of which would vary the Gloucestershire County Council On Street Parking Order 2017 (the 2017 Order) by introducing the proposed restrictions detailed in the Schedule below on Bath Road and Vernon Place, Cheltenham, Gloucestershire. Please note there will be no changes to the permit holder provision for the shared-use Permit Holders/Pay at Machine Bays, only the addition of a no return period.

**No Waiting at Any Time except Taxis 7pm-7am/No Loading Mon-Sat 8:30-9am & 5-5:30pm**

Bath Road (A46)	Along a section on the south-eastern side of its carriageway south-west of its junction with Vernon Place (49332)

**No Waiting except Taxis 7pm-7am**

Road Name & Number	Extent
Bath Road (A46)	Along a section on the south-eastern side of its carriageway between its junctions with Vernon Place (49332) & Bath Parade (C9003)

**Cheltenham Permit Holders Zone 1 or Pay at Machine Mon-Sat 8am-8pm Max Stay 2 Hours No Return 2 Hours, Sunday 8am-8pm Max Stay 3 Hours No Return 2 Hours**

Road Name & Number	Extent
Bath Road (A46)	Along sections on the north-western side of its carriageway between its junctions with Bath Street (49333) & Oriel Road (A46)
