

**TEMPORARY CLOSURE OF PUBLIC FOOTPATH ABA 89 and PART OF  
PUBLIC BRIDLEWAY ABA 87 (BADGEWORTH PARISH) and PUBLIC  
FOOTPATH ACY 24 (COWLEY PARISH) TEWKESBURY BOROUGH  
ORDER 2023**

NOTICE is hereby given that the Secretary of State for Transport has extended the above Order to close temporarily under Sections 14, 15 and 16 of the Road Traffic Regulation Act, 1984 (as amended) part of the Public Footpaths and Public Bridleway as defined in the Schedule below:

**Schedule**

Public Bridleway ABA 87 from its junction with Public Footpath ABA 89 at OSGR SO 93076 15866 and its junction with A417 Road at OSGR OS 93013 15874 in a generally southerly direction for approximately 335 metres to its junction with Public Footpath ABA 88 OSGR SO 93127 15652 shown on the Order Map by a solid black line marked A to B to E.

Public Footpath ABA 89 from its junction with Public Bridleway ABA 87 at OSGR SO 93076 15866 in a generally south easterly direction for approximately 110 metres to its junction with Public Footpath ACY 24 at OSGR SO 93173 15834 and shown on the Order Map by a bold solid black line marked B to C.

Public Footpath ACY 24 from its junction with Public Footpath ABA 89 at OSGR SO 93173 15834 in a generally easterly direction for approximately 235 metres to its junction with A417 Road at OSGR SO 93343 15851 and shown on the Order Map by a bold solid black line marked C to D.


The said Public Footpaths and Public Bridleway fall within the Parishes of Badgeworth and Cowley in Tewkesbury Borough, within the County of Gloucestershire.

The closure is necessary to safeguard the public while site clearance and archaeological digs are undertaken as part of the preparation for the A417 Missing Link Road works.

The Order came into force on the 5<sup>th</sup> June 2023 and was due to expire on 5<sup>th</sup> December 2023. However, works have still not been completed and an extension has been granted by the Secretary of State for Transport and will last until 5<sup>th</sup> March 2027 or until the completion of the works, whichever is the earlier.
