**EARLY YEARS FUNDING PAYMENT
ARRANGEMENTS FOR ACADEMIC YEAR
2025/26**

In April 2024 we moved to monthly instalment payments whilst remaining at one submission of an Actual task at the beginning of the term and the opportunity to amend these claims later in the term with the final amendment payment.

It was agreed that we would review this arrangement after the initial 12-month period. As we approach the end of this academic year, 2024/25, we would like to take this opportunity to conduct that review.

We will report the outcome of this consultation and a timetable for the Early Years funding claims tasks and payment dates, based on the results as soon as possible and before the end of the Summer term, in preparation for September 2025.

Practice Spotlight

Supporting Children's Behaviour

'The provider has high expectations for children's behaviour and conduct, These expectations are commonly understood and applied consistently and fairly....they are beginning to manage their own feelings and behaviour and to understand how these have an impact on others'

This is a grade descriptor for 'Good' within Behaviour and attitudes of the current Early Years Inspection Handbook. When thinking about how children's behaviour is supported in your provision consider:

- Do your behaviour expectations meet the developmental stages of the children
- Have suitable boundaries been established and do children understand these
- Do all staff understand your behaviour policy and how to positively support children's behaviour
- Are staff consistent when applying or reminding children of the boundaries
- Do staff explain why certain behaviours are not acceptable and provide them with ways to manage their behaviour in the future
