The Cycle Spine received recognition at the National Travel Awards.

MT mentioned that Estcourt Road to Elmbridge still has a long way to go. AB noted that this section is included in the Gloucester cycle spine project, with a completion target for Spring 2025. PW highlighted several issues along that route related to broadband, which are prolonging the construction process. DG raised concerns about problems with trees on the Cheltenham section and whether falling trees or storms have had an impact. AB responded that it doesn't appear to be an issue.

CC requested an update on the budget and expressed interest in having a cycle bus at Tewkesbury C of E school. OH is looking into this and will email CC outside of this meeting. There is a legal issue with Tewkesbury Council regarding bikes for borrowing; the bikes are being fully serviced and should be delivered next week. PW thanked the ThinkTravel team for their work.

MT discussed the Rodborough missing link and the connections under the railway bridge. SW proposed a switchback to reduce the gradient, noting a small gap in the network. AB mentioned that it is a technically complex project due to environmental considerations. MT inquired if the Hartpury to Gloucester route is the bridleway, to which SW confirmed it stays to the west of Maisemore and that options are being explored.

Action: OH to email CC regarding the budget update and the interest in having a cycle bus at Tewkesbury C of E.

Action: OH to follow up on the legal issue with Tewkesbury Council regarding the borrowing of bikes, ensuring they are fully serviced and delivered next week.

4.0 Estcourt Road Update

AB provided an update regarding the Estcourt Road junction, noting that various modelling options have been explored, taking into account the 94 bus route that runs through the area. Initially, two options were considered: a Dutch-style roundabout or a signalised Cyclops junction. The Cyclops option encountered significant congestion issues.

The Dutch-style roundabout, similar to one in Cambridge¹, requires consideration of the two traffic lanes on Estcourt Road, which may need to be reduced. Work is currently underway to examine this further. Cambridge officials indicated that appropriate signage is essential to prevent rear-end collisions and to educate drivers, giving users an early understanding of how to navigate the roundabout. Plans include a zebra crossing on each arm.

MT mentioned that a previous experiment to reduce lanes was unsuccessful. AB clarified that this was due to temporary infrastructure like cones. DG emphasised the need for solid infrastructure to change the culture and improve conditions for pedestrians and cyclists. A name change was proposed. PW added that the experiment coincided with nearby roadworks, allowing cyclists to join the roundabout at a normal speed, but highlighted that there have been many casualties at that junction.

5.0 Revised LCWIP/Garden Communities Presentation

PS delivered an update on the LCWIP, noting that the original report included links to Ashchurch and broadly connected to garden community projects. With the garden community progressing, planning applications for significant housing growth are now forthcoming. The LCWIP will be updated to facilitate contributions for the necessary work. Additional routes have been incorporated into the revised report, with aspirations set for routes through these developments.

Priority routes for scheme development have been selected based on forthcoming developments, and feasibility studies have been conducted for these routes. A concept design for the A46 is part of the J9 works, although the M5 bridge presents a constraint. SW remarked that developers are claiming the identified corridor isn't feasible, and justifications have been requested. Development can be refused if there is inadequate access for pedestrians and cyclists, requiring evidence for any statements made. The A46 working group is functioning well, and the borough has produced a charter. SW has a site visit scheduled at a development to the east. DG emphasised the importance of designing developments positively to attract residents.

CC raised concerns about the difficulties of cycling to Northway Station and requested potential improvements. He also mentioned that the Bredon Road junction is problematic and frequently floods. SW acknowledged the challenges of adhering to LTN 1/20 guidance and highlighted issues with protected species along that corridor. Discussions about reducing speeds are ongoing.

CC expressed frustration over the inability to install speed cameras in town due to high speeds, referencing Cinderford's rubber speed bumps as a possible solution. AB noted that while these have been used in the county before, there are pros and cons to all types of infrastructure. PW indicated that Stuart Bullen should have contacted CC regarding concerns about cameras. There are issues with thresholds for the number of people receiving letters, with the current threshold set too high; GCC aims to support a reduction in this threshold in the future. RV suggested that addressing this should not take long among staff members, and CC confirmed that they would provide the camera initially promised.

CC expressed disappointment over missed opportunities in some developments. PS explained that the consented site is to the south, where connections are challenging, and contributions may have been made in other ways. NM asked if someone from planning should attend the next CAG meeting, and CC agreed to provide the best contact.

CC mentioned that the M5 bridge is unsafe for cyclists, forcing many to use the pavement due to dangerous conditions. AB stated that officers are collaborating with Tewkesbury to explore further assistance with the missing bridge to the north. PW raised concerns about crossing Ashchurch Road and the north/south linkages, noting that the road is too narrow for refuge islands but suggested considering more suitable crossings for cyclists. PW also mentioned efforts to recruit additional development control officers who will need access to a local wish list map and LCWIP aspirations, emphasising the opportunity in Gloucester to secure developer contributions. SW concluded that there is a renewed focus on corridor work to advance these efforts, while PS confirmed that the map is being updated.

Action: RV to engage with staff to address the speed camera issue and ensure timely follow-up on concerns raised by CC.

Action: CC to invite someone from Tewkesbury Planning to attend next CAG meeting.

6.0 Updates on Operation Close Paths

RV advised that dash cam footage is being submitted, highlighting issues it causes for cyclists when supplying evidence of incidents (being passed at less than 1.5m). He noted that the offence alone is insufficient for enforcement unless additional evidence is available. The police plan to send out advisory letters to educate drivers about these issues and will prosecute where there is sufficient evidence, aiming to enhance driver awareness.

SW inquired about the outcomes of advisory letters regarding speeding. The police responded that a second letter is sent out, which has led to a reduction in speeding issues. Only 20% of drivers who receive a first letter end up getting a second one.

SW suggested that the police attend the cycling forum and bring a copy of the advisory letter for discussion.

Action: SW to coordinate with the police to arrange their attendance at the cycling forum and facilitate a discussion regarding the advisory letter and its implications for cyclist safety.

7.0 Maintenance Responsibility Issues

AB provided an update on behalf of the team, reporting that 10 days of sweeping and maintenance work have been conducted on the spine this year, which will become a regular practice. The team is currently working with the NHS to borrow their sweeper for trial purposes, and a meeting has been scheduled to develop a maintenance policy. GGC intends to procure its own sweeper for future maintenance, which will have additional capabilities such as weed spraying. Trials will first be conducted on the cycle spine before extending to the rest of the cycle network.

RS mentioned difficulties in reporting debris on FixMyStreet, which is currently not functioning. AB will inquire about the issue and see if it can be included on the website. General maintenance responsibilities revert to the borough, and users are advised to report obstructions using free text.

8.0 AOB

AB received a detailed response following recent meetings with Councillor DW and NH over the past two months regarding Elmbridge. NH provided an update on lighting upgrades, with hopes to progress soon, although nothing is confirmed yet. Vegetation work has been addressed, and the team will review the actions taken by NH in this area.

CC provided feedback that the green loop surface on the cycle spine is not suitable for road bikes. AB noted that the majority of the route uses the same product specification. PW explained that concerns regarding tyre performance primarily relate to users with high-performance tyres. The entire road has been resurfaced as an alternative solution. JH suggested that this issue should be kept under review and that specific locations could be identified. AB confirmed that comments regarding motorist abuse have been relayed to the communications team.
