GLOUCESTERSHIRE COUNTY COUNCIL ON STREET PARKING ORDER 2017 (VARIOUS ROADS, CHELTENHAM TRANSPORT PLAN PHASE 4) (EXPERIMENTAL VARIATION) (AMENDMENT NO. 1) ORDER 2019

NOTICE is hereby given that Gloucestershire County Council has made an Experimental Variation Amendment No. 1 Order under the Road Traffic Regulation Act 1984, the effect of which will experimentally vary the Gloucestershire County Council On Street Parking Order 2017 ("the 2017 Order") by experimentally introducing the restrictions described in the Schedule below (which will experimentally replace any current restrictions on those specific lengths of roads) along Various Roads within the Borough of Cheltenham, Gloucestershire.

The Experimental Variation Amendment No. 1 Order is Experimental and may continue in force for a period of up to 18 months from the date of the original experimental order expiring on 28th December 2019. In due course the Council will consider whether or not the provisions of the Experimental Variation Amendment No. 1 Order should continue in force indefinitely.

Within 6 months of coming into force of the Experimental Variation Amendment No. 1 Order any person may object to its indefinite continuation. Any such representation should be sent in writing to the Head of Legal Services, Shire Hall, Westgate Street, Gloucester, GL1

, or via the Portal found at www.goucestershire.gov.uk/ctp-phase4 not later than 3rd December 2019 stating the grounds on which it is made (please quote reference HBL/64805).
