

## **National Wraparound Childcare Programme**

As part of the government programme to help working parents the local authority are working with schools, private voluntary and independent providers including early years settings and childminders to ensure there is sufficient sustainable childcare to support parents who have primary school age children to access care from 8am to 6pm during term times.

As the new Early Years and Childcare Sufficiency and Business Manager (Wraparound care) I will be attending the information sessions to provide an overview of this programme and to answer any questions you may have if you are considering creating new or wanting to expand existing wraparound provision. I can let you know what the local authority are doing and update you on the national programme.
