

<p>Broad Description of Site (including current activities on site, location and neighbouring uses)</p>	<p>The site consists of four areas split by the B4063 Cheltenham Road East. To the north west of the site there is section of open space which was allocated in the Waste Local Plan. Neighbouring is the Dowty factory and Ashville Business Park. Ashville Business Park consists of a group of relatively new units. On the opposite side of the B4063 is Meteor Business Park, which contains a number of older industrial units and a car showroom. On Ashville Business Park there are the following businesses: Cheltenham and Gloucester Mercedes Benz, Chrysler Jeep as well as St Johns Ambulance and Staverton ambulance station. On Meteor Business Park there are the following uses: Mitsubishi Motors, Staverton building supplies, mobile home sales, Clarkson Evans, Severn Trent storage. Good access from B4063 Cheltenham Road East. All parts of the site have a good internal road network. Mainly small businesses. There are a couple of dwellings within the vicinity, Brickhampton Golf Course and Staverton airport. Some countryside and other other businesses surrounding and generally all parts of the site are open. There are a few trees, but it might be challenging to screen the site.</p> <p>Additional Sensitive Receptors: Sports ground, club.</p>





Additional Comments	Designated as a 0 as the site is within Staverton World War II airfield, and contains four World War II pill boxes (SMR 7112), the full significance of which cannot be determined without further analysis.

Comment	The site is not classified as "Contaminated Land" under Section 2a of the Environmental Protection Act 1990, however Tewkesbury Borough Council identified the site as a site of concern with the comment that there are "some potentially contaminative issues" associated with the site.

Flood Risk <i>(Based on information provided by Halcrow)</i>	
Site Description	Site lies predominantly in Flood Zone 1. The Hatherley Brook enters the site along the eastern boundary at SP 8821 2239 and flows through the site for approximately 170m before exiting the site and forming part of the site boundary. Flood Zone 2 extends into a small part of the site but Flood Zones 3a and 3b are shown to remain in bank for the parts of the watercourse that flow through the site.
Watercourse(s)	Hatherley Brook
Flood Zone	1,2, 3a and 3b
Flood Zone Information (Method used to derive Flood Zones & Confidence in Flood Zone information)	Modelled flood outlines have been produced for Flood Zones 2, 3a, 3b and the 100 year climate change event.
Fluvial Flood Risk Posed to Site (including climate change)	Site lies predominantly within Flood Zone 1 although parts of the site are shown to be affected by Flood Zone 2 where the watercourse flows through part of the north eastern extent of the site. Modelled flood outlines for the 100 year climate change event indicate that in general the watercourse will remain within bank. Recent fluvial flooding recorded in July 2007 indicates that parts of the site adjacent to the watercourse are at risk from fluvial flooding.
Historic Flooding/Flooding From Other Sources	Historic flood outlines for the Hatherley Brook indicate that parts of the site adjacent to the watercourse have been affected by flooding in July 1968 and more recently in July 2007. The area shown to have been affected by flooding in July 2007 is greater in extent than Flood Zone 2. No records of flooding from other sources including groundwater and surface water have been recorded on the site.

General Comments

Officer Comments: There are likely to be deliverability and potential issues with existing use classes associated with this site. There are sensitive receptors which would also need consideration. The site boundary needs modification to remove areas of flood risk and non-B1, B2, B8 uses.

PRoW/Ecology/Biodiversity/Archaeology: Further consultation would be required in order to assess any potential impacts upon the above mentioned areas.

Safeguarding: Gloucestershire Airport need to provide comments on safeguarding in relation to this site. This may be difficult for them to do so without knowing a specific technology for the site.

Contaminated Land: Further investigative work may be required.

Groundwater/Aquifer: Information would be required from the Environment Agency as to the potential impacts upon the above mentioned areas.

Potential for Further Discussion within the WCS

The site is undeliverable and therefore has no potential for further discussion within the WCS.
