

**PUBLIC NOTICE**  
**GLOUCESTERSHIRE COUNTY COUNCIL**  
**ON STREET PARKING ORDER 2017 (VARIOUS ROADS, ABBEYDALE, ABBEYMEAD AND**  
**BARNWOOD WARDS) (CITY OF GLOUCESTER) (VARIATION) ORDER 2026**

NOTICE is hereby given that Gloucestershire County Council intend to make a Variation Order under Sections 1, 2, 3, 4 & 5 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers, the effect of which would vary the Gloucestershire County Council On Street Parking Order 2017 (the 2017 Order) by introducing the proposed restrictions detailed in the Schedule below on various roads in the City of Gloucester.
