

## PUBLIC NOTICE

**GLOUCESTERSHIRE COUNTY COUNCIL  
BUS LANE ORDER 2017  
(CLARENCE STREET AND NORTH STREET, CHELTENHAM TRANSPORT PLAN  
PHASE 4)  
(EXPERIMENTAL VARIATION) ORDER 2018**

NOTICE is hereby given that Gloucestershire County Council made an Experimental Variation Order (the Experimental Variation Order) under the Road Traffic Regulation Act 1984, the effect of which will be to experimentally vary the Gloucestershire County Council Bus Lane Order 2017 (the Bus Lane Order) by experimentally introducing the Bus Gate described in the Schedule below along Clarence Street and North Street within the Borough of Cheltenham, Gloucestershire.

### THE SCHEDULE

**Bus Gate to be introduced between the hours of 10:00 and 18:00**

Road Name / Number	Extent
Clarence Street A46	From a point approximately 14m north east of the centre point of its junction with Imperial Circus to its junction with High Street / North Street
North Street A46	From its junctions with High Street / Clarence Street to its junction with Albion Street

The remainder of the Bus Lane Order will remain in full force and effect.

A copy of the Experimental Variation Order which comes into effect on 28<sup>th</sup> June 2018, the Bus Lane Order, the sealed plan to be inserted into the Schedule of Bus Lane Order Plans together with a copy of the Statement of Reasons and other documents, may be inspected during normal opening hours at Gloucestershire County Council, Shire Hall, Westgate Street, Gloucester, GL1 2TG, Cheltenham Borough Council, Municipal Offices, Promenade, Cheltenham, GL50 9SA and Cheltenham Library, Clarence Street, Cheltenham, GL50 3JT or can be viewed at [www.gloucestershire.gov.uk/ctp](http://www.gloucestershire.gov.uk/ctp) (Please quote reference HBL/64805).

The Experimental Variation Order is Experimental and may continue in force for a period of up to 18 months expiring on 28<sup>th</sup> December 2019. In due course the Council will consider whether or not the provisions of the Experimental Variation Order should continue in force indefinitely.

Within 6 months of coming into force of the Experimental Variation Order any person may object to its indefinite continuation. Any such representation should be sent in writing to the Head of Legal Services, Shire Hall, Westgate Street, Gloucester, GL1 2TG or via the Portal found at [www.gloucestershire.gov.uk/ctp-phase4](http://www.gloucestershire.gov.uk/ctp-phase4) not later than 7th January 2019 stating the grounds on which it is made (please quote reference HBL/64805).
