

**GLOUCESTERSHIRE COUNTY COUNCIL**  
**(PROHIBITION OF RIGHT AND LEFT TURNS) (BLACK DOG WAY/BRUTON**  
**WAY/LONDON ROAD/NORTHGATE STREET AREA) (GLOUCESTER CITY)**  
**ORDER 2026**

The Gloucestershire County Council ("the Council") in exercise of its powers under Sections 1, 2, and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Parts II and IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of that Schedule hereby make the following Order:-

1. (i) This Order shall come into operation on the 24<sup>th</sup> day of March 2026 and may be cited as the "GLOUCESTERSHIRE COUNTY COUNCIL (PROHIBITION OF RIGHT AND LEFT TURNS) (BLACK DOG WAY/BRUTON WAY/LONDON ROAD/NORTHGATE STREET AREA) (GLOUCESTER CITY) ORDER 2026".  
  
(ii) The Order affects roads in the Westgate and Kingsholm & Wotton Wards in the City of Gloucester within the County of Gloucestershire.
2. In this Order  
  
"Motor Vehicle" means a mechanically propelled vehicle intended or adapted for use on the roads as defined in Section 185 of the Road Traffic Act 1988;  
  
"Pedal Cycle" means a unicycle, bicycle, tricycle or cycle having four or more wheels, not being in any case mechanically propelled unless it is an electrically assisted pedal cycle of such class as is treated as not being a motor vehicle for the purposes of the Act;  
  
"Vehicle" means a Motor Vehicle or any other vehicle unless specifically exempted by the provisions of this Order.
3. Save as provided in Article 5, no person shall cause or permit any Vehicle, including a Pedal Cycle, except with the permission of a Police Officer in uniform, to make a right turn manoeuvre from the roads described in Column 1 of Schedule 1 to this order ("Schedule 1") into the roads described in Column 2 of Schedule 1 ("the Schedule 1 Roads").
4. Save as provided in Article 5, no person shall cause or permit any Vehicle, including a Pedal Cycle, except with the permission of a Police Officer in uniform, to make a left turn manoeuvre from the road described in Column 1 of Schedule 2 to this order ("Schedule 2") into the road described in Column 2 of Schedule 2 ("the Schedule 2 Roads").
5. Nothing in Articles 3 or 4 shall render it unlawful to cause or permit any Vehicle to make a prohibited manoeuvre into the Schedule 1 Roads and the Schedule 2 Road so long as is necessary if the Vehicle is being used for Police, Fire

Brigade or Ambulance purposes in the pursuance of their duties in the case of dealing with an emergency.


