If we don't proceed with the diversion as proposed, then the county council will ensure that the existing footpath route is reinstated through The Redlands and the neighbouring property, so that those wishing to use the footpath will have full access to it, as they are entitled to do so.

If we do proceed with the diversion, formal consultation will be carried out, with the proposal being advertised locally, on site and in the local press. Anyone will be able to submit comments on it and these will be taken into account in any subsequent decision-making, before the order is confirmed or abandoned. In any event, it is likely that the case will be referred to an independent inspector appointed by the Secretary of State for a decision on whether to implement the diversion.

The legal criteria by which the diversion is being considered are set out in section 119 of the Highways Act 1980 and I attach a "Statement of Reasons" which sets out the proposal in full, together with a plan showing the proposed diversion.

If you wish, you can send me any comments you might like to make on the proposed diversion before we reach the formal consultation stage and I can pass them on to my colleague who is dealing with the case. However, you may just like to wait until I'm in a position to confirm to you if the applicants now intend to pursue the diversion. When weighing up the merits of the diversion proposal, any unauthorised obstructions along the existing footpath route (i.e. parked vehicles, garden fences, shrubs etc) should be disregarded. Any works that are needed to the proposed replacement footpath will be undertaken at the appropriate time, including waymarking and drainage improvements if needed.

I hope all this is clear but please don't hesitate to ask if you would like any further details about this matter. I apologise again for the length of time it is taking to resolve this issue and hope that we'll soon be in a position to either reinstate the existing legal route or provide an acceptable alternative route before too much longer.



Thank you for your emails- you were on my list to reply to this week.

We have been seeking the views of the applicants on whether or not they wish to proceed with the proposed diversion, given the fact that we have received other correspondence suggesting that objection(s) could be submitted to the order if and when it's made.

Unfortunately, the applicants have been slow to respond so we have given them a deadline of the 8th September to supply the information we have asked for.

If we don't receive a meaningful response by that date, then we will proceed to enforce the current legal line of the footpath. This will mean removing all the obstructions on it, ensuring that there is a convenient means of access (eg. a gap or gate) in the boundary between Meadow View and the field behind it and also in the far boundary of that field. The path will also be clearly sign-posted.

I apologise again for the lack of progress to date on this issue, but we will be able to move forward with resolving this matter one way or another, within the next 4 weeks or so.




