

**GLOUCESTERSHIRE COUNTY COUNCIL**  
**(NO ENTRY) (B4063 CHELTENHAM ROAD EAST/PIRTON LANE)**  
**(TEWKESBURY BOROUGH) ORDER 2025**

Gloucestershire County Council ("the Council") in exercise of its powers under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Parts II and IV of Schedule 9 of Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of that Schedule, hereby make the following Order:-

1. (i) This Order shall come into operation on **18<sup>th</sup> December 2025** and may be cited as the "Gloucestershire County Council (No Entry) (B4063 Cheltenham Road East/Pirton Lane) (Tewkesbury Borough) Order 2025".  
  
(ii) This Order affects roads in the Churchdown St John's Ward within the Borough of Tewkesbury in the County of Gloucestershire.
2. In this Order –  
  
"Local Bus" means a Public Service Vehicle used in the provision of a Local Service not being an excursion or tour;  
  
"Local Service" has the meaning given in section 2 of the Transport Act 1985;  
  
"Motor Vehicle" means a mechanically propelled vehicle intended or adapted for use on the roads as defined in Section 185 of the Road Traffic Act 1988;  
  
"Pedal Cycle" has the same meaning as in Regulation 4 of the Traffic Signs Regulations and General Directions 2016 and means a unicycle, bicycle, tricycle, or cycle having four or more wheels not being in any case mechanically propelled unless it has electrically assisted pedal cycle of such class as to be treated as not being a Motor Vehicle for the purposes of the Act;  
  
"Public Service Vehicle" has the meaning given in section 1 of the Public Passenger Vehicles Act 1981;  
  
"Vehicle" means a Motor Vehicle or any other vehicle including a Pedal Cycle unless specifically exempted by the provisions of this Order
3. No person shall cause or permit any Vehicle except with the permission of a Police Officer in uniform to enter the road stated in Column 1 to Schedule 1 to this Order ("the Bus Stop") from the road described in Column 2 to Schedule 1 to this Order ("the Main Road")
4. Nothing in Article 3 shall render it unlawful to cause or permit a Local Bus to enter the Bus Stop from the Main Road.

5. Nothing in Article 3 shall render it unlawful to cause or permit a Vehicle to be used for Fire and Rescue, Police or Ambulance emergency service purposes to enter the Bus Stop from the Main Road.
6. No person shall cause or permit any Vehicle except with the permission of a Police Officer in uniform to enter the road stated in Column 1 to Schedule 2 to this Order ("the Bus Stop") from the road described in Column 2 to Schedule 2 to this Order ("the Side Road")
