Did you know that if you're already registered as a childminder with Ofsted, you can also operate as a nanny using your current registration.

All you need to do is contact Ofsted to let them know that you want to start providing this type of care. They'll then send you an updated certificate. You can [email Ofsted](#) from the email address they have on record.


