INTRODUCTION

THANK YOU FOR TAKING AN INTEREST IN PARKING IN GLOUCESTERSHIRE.

2013-2014 has seen some important developments in the county. The county council, working with our partner councils across the county, gave notice that the current on-street (on the public highway) enforcement arrangements whereby each district or borough council enforced parking restrictions in each of their areas would cease to operate from the 31st March 2013. A review of parking services resulted in a contract for the provision of enforcement patrols and administrative functions being awarded to APCOA and a new countywide on-street parking enforcement regime took effect from the 1st April 2013.

The individual district, borough and city councils within the county retained management and control of their car parks and privately owned car parks and off-street parking areas were, of course, unaffected by the change.

Under the new arrangements, highways within Gloucester City and the Forest of Dean will continue to be patrolled and enforced under arrangements managed by the city and district councils until the end of August 2014, when the roads in both of these areas will fall within the county council led scheme. All highways in Cotswold, Stroud Districts, Cheltenham and Tewkesbury Boroughs will be patrolled by staff employed and supervised by APCOA but under the direction of staff within the county council's Parking Team. Whilst the administration of all appeals (challenges, representations and appeals) are now carried out by APCOA staff, their work is closely supervised by the county's Parking Team who fully review all cases and make any decisions following a challenge, representation or other contact made over the issue of Penalty Charge Notices ("PCN").

During the year a new process has been adopted for issuing and managing all permits, vouchers and waivers issued for on-street parking, as well as adding to drivers ability to "pay by phone" when parking in a pay-and-display space. A mobile phone app and a new website have added convenience and flexibility to the process of buying permits. In addition, the pay-by-phone parking and the new virtual (digital) process has reduced fraud and the cost of managing the system.

These changes have ensured that parking is both managed and enforced in a clear and consistent way across the county whilst reducing costs and introducing the potential for flexibility when looking at individual solutions for local parking problems.

We intend to build on these improvements and continue to introduce new, flexible and efficient methods and practises over the coming year.

THE RESIDENT PARKING REVIEW

A series of reviews of parking restrictions within highly populated and visited urban areas has been underway since late 2010. The following is a summary of the work undertaken in 2013-2014.

The purpose of parking reviews

Implementation of new permit parking zones in Gloucestershire has contributed towards achieving a number of GCC transport objectives in the county and have all been identified within the third Local Transport Plan (LTP3), which was adopted in April 2011. Key policy commitments in LTP3, and its supporting document, “The Gloucestershire Parking and Demand Management Strategy” relating to the zones project include the following:

- i. To discourage commuter parking in the town and city centres, through supply and pricing mechanisms, to actively encourage the use of Park & Ride schemes, public transport and low carbon forms of travel.
- ii. To work with the borough and district councils through the Parking Boards to ensure that parking policies in each area support the local economy and provide good access to services but through supply and pricing, do not undermine the use of public transport and low carbon forms of travel
- iii. To set tariffs and use marketing for central off-street and on-street car parking to give priority for shoppers and visitors, and to direct commuters to sites further away from the centre and park and ride sites.

The parking review programme will consider towns across the county in a phased approach – in 2013/14, the review has focused on Cheltenham and Cirencester.

CIRENCESTER

The Cirencester Parking Review began in the summer of 2012. Gloucestershire County Council (GCC) has been working in partnership with the district and town councils, and Chamber of Commerce so that all aspects of on and off-street parking can be considered together.

Early stages of the review considered a wide area across the town centre (within the ring road). Having considered the feedback from local people, the partnership group requested GCC focus on addressing issues with existing permit schemes in the very central streets of the town, where parking is particularly congested, and there are lots of competing demands for the available spaces.

In response GCC developed proposals and published them for consultation in March 2014. At the Feedback to that consultation highlighted a strong split in opinion amongst local residents and visitors to the town that could not be reconciled. There was little prospect of finding an effective solution to parking issues in the town on which all parties agreed, and hence the proposed changes were abandoned.

As part of the Cirencester Parking Review, the district council have provided cheap all day parking in a peripheral car park (Beeches CP) and are developing improvements to other car parks in the town.

PITTVILLE


In 2013, GCC conducted a review of parking in the Pittville area of Cheltenham. The review included a number of consultation events with local residents, businesses and other organisations in the neighbourhood.

Existing issues with parking arrangements were highlighted through this review – these included:

- Congested parking into the evenings and weekends near the town centre;
- Requests to extend the operating hours of existing permit parking schemes in the area;
- Congested parking around Pittville Park due to long-stay visitor (commuter) parking.

To address these issues, the county council published proposals for a new permit parking scheme covering much of the Pittville area. These proposals were presented for consultation in October 2013.

Having considered all the feedback received during the consultation process, a decision has been taken to implement the proposed scheme which is expected to be operational by summer 2014.



ST PAUL'S PARKING REVIEW

The Parking Team has also conducted a review of parking in the St Paul's area of Cheltenham. Through consultation events, existing issues with parking arrangements were highlighted, including:


- Congested parking into the evenings and weekends near the town centre;
- Multiple occupancy housing contributing to parking congestion;
- Significant levels of commuter parking.

GCC also received many complaints from local residents about parking in St Paul's. As a result of this we investigated the problem and began talking to local resident groups and other organisations.

A parking survey has confirmed severe parking congestion in the area, and provided a lot of information about the nature of the problem. Planned developments at North Place/Portland Street risk increasing pressure on local parking.

The Parking Team believes that a new area-wide permit parking scheme would address these problems.

A new permit scheme would help to share the available parking more fairly, and make it more likely residents could find a parking space near their home. However, people would be required to pay for a permit, and buy vouchers for visitors.



ASHFORD ROAD AREA


Following a significant number of requests for a permit scheme in this area including a petition, it was proposed to introduce a new permit parking scheme covering Ashford Road and the surrounding streets.


Feedback to the consultation process demonstrated a split in opinion amongst local residents, and the scheme was referred to the Traffic Regulation Committee for their consideration. After a public debate, the committee recommended the permit scheme should not go ahead, and just some small changes to no waiting restrictions on Shurdington Road were progressed.

A final decision has now been taken, in line with the committee's recommendations; the proposed permit zone in that area was abandoned.

PAY AND DISPLAY MACHINE LOCATIONS IN GLOUCESTER AND CHELTENHAM



P&D INCOME

The following chart shows the income from on street Pay and Display parking in Cheltenham Borough, Cotswold District and Gloucester City Council areas



The resulting income from on-street P&D charges is approximately £160-£180,000 per month. Approximately one third of the income is collected from Gloucester, and two thirds from Cheltenham. There was no P&D income from Cotswold District in April/May as the only P&D machines on Market Place, Cirencester were temporarily out of order.

CONTRACT MANAGEMENT

On 1 April 2013 Gloucestershire County Council (GCC) took over responsibility for on-street enforcement in Cheltenham Borough, Tewkesbury Borough, Stroud District and Cotswold District. At the same time, APCOA, was awarded a contract to undertake parking enforcement within these districts.

By working in close partnership, GCC's Parking Team assists APCOA to deliver a cost effective service. Performance monitoring enables GCC to improve delivery in areas such as:

- **Patrol routes** – to better target resources, to improve coverage throughout the county, enhance road safety, work with schools, the police, parish and district councils, residents' groups, and traders' associations.
- **Special events** – to ensure that they are a success; traffic management plays a significant role in this. For example – Cheltenham Races, Cheltenham Jazz Festival, and Cheltenham Literature Festival.
- **Administration processes that deal with challenges and appeals** – to improve the customer experience after a PCN has been issued, to provide guidance and recommendations on correspondence, to ensure all correspondence is correctly responded to (and in a timely manner), and to implement procedures and systems of work to achieve compliance at all stages of the PCN process.





The Key financial trends in on-street parking enforcement are demonstrated in the graph below:





The number of PCNs issued gradually increased throughout the year with a slight up-turn in March 2014.














The map above shows both established and new CCTV sites in Gloucestershire.



The flow chart above illustrates the potential “life cycle” of a PCN with the opportunities to challenge and pay.


Appeals and Representations


PARK AND RIDE REPORT (January 2013 until February 2014)




