

**GLOUCESTERSHIRE COUNTY COUNCIL**  
**(ONE WAY) (VARIOUS ROADS WITHIN GLOUCESTER CITY)**  
**ORDER 2019**

The Gloucestershire County Council ("the Council") in exercise of its powers under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Parts II and IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of that Schedule hereby make the following Order:-

1. (i) This Order shall come into operation on the 3<sup>rd</sup> February 2020 and may be cited as the "Gloucestershire County Council (One Way) (Various Roads Within Gloucester City) Order 2019;
- (ii) The roads described in Schedule 1 to this Order ("Schedule 1") fall within the boundary of Gloucester City in the County of Gloucestershire ("the Roads");
2. In this Order –  
  
"Motor Vehicle" means a mechanically propelled vehicle intended or adapted for use on the roads as defined in Section 185 of the Road Traffic Act 1988;  
  
"Pedal Cycle" has the same meaning as in Regulation 4 of the TSRGD and means a unicycle, bicycle, tricycle or cycle having four or more wheels not being in any case mechanically propelled unless it has an electrically assisted pedal cycle of such class as to be treated as not being a Motor Vehicle for the purposes of the Act  
  
"Vehicle" means a Motor Vehicle or any other vehicle unless specifically exempted by the provisions of this Order
3. No person shall cause or permit any Vehicle except on the direction or with the permission of a Police Officer in uniform from proceeding along the Roads other than the way described in Schedule 1.
4. Nothing in Article 3 shall render it unlawful to cause or permit a Pedal Cycle to proceed along the Roads numbered 1, 8, 9 and 10 against the directions referred to in Schedule 1.
5. Nothing in Article 3 shall render it unlawful to cause or permit a Vehicle to proceed along the Roads against the directions referred to in Schedule 1 as may be necessary to enable the following should there not be an alternative access or egress:-
  - (a) the mechanical cleansing of any of the Roads or side of roads as part of a local authority service; or
  - (b) the Vehicle to be used for Fire and Rescue, Police or Ambulance emergency service purposes.
6. The One Way restriction described in Schedule 2 to this Order is hereby revoked.

7. The Orders or parts of Orders referred to in Schedule 3 to this Order are hereby revoked.

10.	Berkeley Street	From its junction with Westgate Street to a point 5 metres north of its junction with Longsmith Street	South-westerly
11.	Hare Lane	From its junction with Northgate Street to its junction with Pitt Street	North-westerly
12.	Skinner Street	From its junction with St Catherine Street to its junction with Kingsholm Road/ Worcester Street	North-easterly
13.	St Catherine Street	From its junction with Worcester Street to its junction with Skinner Street	Easterly
