## Wednesday 8 May at 8.30am - Review of Operation Encompass

The Safeguarding in Education team will be delivering the next DSL support hub on Wednesday 8<sup>th</sup> May 2024. This 30-minute session will be led by Chris Miller (Independent Consultant) who has been commissioned by the Safeguarding Children Partnership (GSCP) to undertake an independent review of Operation Encompass. Chris has asked to attend our DSL Support Hub to gain your views and opinions on the current functionality of Operation Encompass.

In preparation for this could you please consider the following questions:-

- Do you receive Encompass notifications in time for the start of the next school day after the incident?
  - If not, how often is the target missed?
- Does the referral provide you with the information you need to understand what has happened?
  - If not, how do the notifications fall short of what you would like to receive?
- Do you have a secure Encompass email. Who can access it ? What is your contingency for when the DSL is absent?
- There is free online Encompass training - have you undertaken it ?
- There is free online Encompass advice and guidance material - do you use it ? If so how often?
- Do your parents know that your school takes part in Encompass - how have you told them?
  - if schools want to share any materials ( letters/ website links ) about this that would be helpful
- How do you use the notifications ?
  - Do you keep records of how you use them?
