

**GLOUCESTERSHIRE COUNTY COUNCIL
ON STREET PARKING ORDER 2017
(NORTHGATE STREET, BLACK DOG WAY, BRUTON WAY, LONDON ROAD &
GREAT WESTERN ROAD) (WESTGATE WARD) (GLOUCESTER CITY)
(VARIATION) ORDER 2026**

Gloucestershire County Council in exercise of its powers under Sections 1, 2, 3, 4, 5, 32, 35, 36 and 39 of Part I and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the 1984 Act) and the Traffic Management Act 2004 (the 2004 Act) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order.

1. The Gloucestershire County Council On-Street Parking Order 2017 (“the 2017 Order”) shall be amended by the revocation of the existing sealed plans specified in the First Schedule to this Order which are hereby replaced with the new sealed plan(s) specified in the Second Schedule to this Order.
2. The effect of this Order is to introduce/voke the restrictions set out in the Third Schedule to this Order.
3. The remainder of the 2017 Order shall remain in full force and effect.

This Order shall come into effect on the **day of 2026** and may be cited as the “GLOUCESTERSHIRE COUNTY COUNCIL ON STREET PARKING ORDER 2017 (NORTHGATE STREET, BLACK DOG WAY, BRUTON WAY, LONDON ROAD & GREAT WESTERN ROAD) (WESTGATE WARD) (GLOUCESTER CITY) (VARIATION) ORDER 2026”

Great Western Road	On part of both sides of the carriageway between its junction with London Road (B4063) and the entrance to Royal Lane (482606)
London Road (B4063)	On part of both sides of the carriageway between its junction with Black Dog Way (A430) and its junction with Great Western Road (480518)
