

**GLOUCESTERSHIRE COUNTY COUNCIL
ON STREET PARKING ORDER 2017
(DIAMOND ROAD & PLATINUM DRIVE) (ASHCHURCH RURAL PARISH)
(TEWKESBURY BOROUGH) (VARIATION) ORDER 2025**

Gloucestershire County Council in exercise of its powers under Sections 1, 2, 3, 4 & 5 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the 1984 Act) and the Traffic Management Act 2004 (the 2004 Act) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order.

1. The Gloucestershire County Council On-Street Parking Order 2017 ("the 2017 Order") shall be amended by the revocation of the existing sealed plan specified in the First Schedule to this Order which is hereby replaced with the new sealed plan(s) specified in the Second Schedule to this Order.
2. The effect of this Order is to introduce the restrictions set out in the Third Schedule to this Order.
3. The remainder of the 2017 Order shall remain in full force and effect.
4. This Order shall come into effect on the **day of 2025** and may be cited as the "GLOUCESTERSHIRE COUNTY COUNCIL ON STREET PARKING ORDER 2017 (DIAMOND ROAD & PLATINUM DRIVE) (ASHCHURCH RURAL PARISH) (TEWKESBURY BOROUGH) (VARIATION) ORDER 2025"
