

PUBLIC NOTICE
GLOUCESTERSHIRE COUNTY COUNCIL
VARIOUS CONSULTATIONS RELATING TO GLOUCESTER CITY CENTRE CYCLE
SPINE MAJOR PROJECT 2025 (WESTGATE WARD) (GLOUCESTER CITY)

Notice is hereby given that Gloucestershire County Council in exercise of its enabling powers under Sections 1, 2, 3, 4, 23 and 84 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and Sections 65, 66 and 90A of the Highways Act 1980 intends:

1. To reduce the speed limit to 20mph as described in Schedule 1 below; and
2. To introduce continuous footway crossings and alter/improve/remove existing road humps and introduce a new junction table as described in Schedule 2 below; and
3. To introduce/upgrade/relocate formal pedestrian/cycle crossing facilities as described in Schedule 3 below; and
4. To make improvements to the existing Gloucester City Cycle Route by upgrading parts of the existing footways by reshaping and resurfacing, removing parts of the existing advisory cycle lane and introducing a section of shared use footway/cycleway and sections of new segregated footways/cycleways; and
5. To introduce/revoke waiting and loading restrictions as described in Schedule 4 below; and
6. To prohibit all vehicles from making certain turning manoeuvres as described in Schedule 5 below; and
7. To reverse the direction of the existing one way on Northgate Street as described in Schedule 6 below; and
8. To reverse the existing bus gate on Northgate Street as described in Schedule 7 below.

A 'Parallel Crossing' is a combined pedestrian and cycle crossing which has priority over the road which it crosses. It consists of a zebra crossing with a parallel priority cycleway and beacons at both ends of the crossing.
