**(VARIOUS ROADS IN THE TWIGWORTH GREEN PHASE 1A DEVELOPMENT) (PARISH OF TWIGWORTH) (TEWKESBURY BOROUGH) (VARIATION) ORDER 2025**

NOTICE is hereby given that Gloucestershire County Council intend to make a Variation Order under Sections 1, 2, 3, 4 & 5 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers, the effect of which would vary the Gloucestershire County Council On Street Parking Order 2017 (the 2017 Order) by introducing the proposed restrictions detailed in The Schedule below on Various Roads in the Twigworth Green Phase 1a Development, Twigworth, Gloucestershire.

**THE SCHEDULE**

Restrictions to be introduced

***No Waiting at Any Time (Double Yellow Lines)***

<b>Road Name &amp; Number</b>	<b>Extent</b>
Ironbridge Road (82319)	Along sections on both sides of its carriageway between its junctions with Tewkesbury Road and Ironbridge Road (72667)
Apley Road (82310)	Along a section on both sides of its carriageway north-east of its junction with Ironbridge Road (82319)
Barley Drive (82308)	Along sections on both sides of its carriageway north-east of its junction with Ironbridge Road (82319)  Along sections on both sides of its carriageway north east of its internal junction along the section of carriageway on approach to the Twigworth Local Centre
Leighton Close (82320)	Along a section on both sides of its carriageway at its junction with Ironbridge Road (82319)  Along a section on both sides of its carriageway at its internal loop road junction.
Carrington Road (82322)	Along a section on both sides of its carriageway at its junction with Ironbridge Road (82319)

The lengths of roads fall within the Parish of Twigworth in the Tewkesbury Borough within the County of Gloucestershire.
