## **Unable to offer a child a place at your setting?**

We understand that you are all receiving additional requests from parents for placements for their child. If you are unable to offer a place, and the parent has disclosed that their child has additional needs, would you please sign post them to the EYService AdviceLine ([EYAdviceLine@gloucestershire.gov.uk](mailto:EYAdviceLine@gloucestershire.gov.uk)) 01452 425959 for support to find a placement. Please note that we would ask that you only do this for children whose needs are high enough for you to consider that you are unable to meet needs within your current cohort and **not** for children where you simply do not have sufficient places.

## **Ofsted replaces EY3 form with a new process for reporting changes to registered people**

Ofsted has today confirmed that it has removed the EY3 (*Report changes to registered people in a nursery or other daycare*) form from the Gov.uk website, and replaced it with a new process for providers to notify them of changes to registered people.

Under the new process, nominated individuals should email [enquiries@ofsted.gov.uk](mailto:enquiries@ofsted.gov.uk), using the email address associated with their Ofsted registration.

In the email, the nominated individual should include the following:

- the words 'report association changes' in the subject line
- their organisation's unique reference number (URN)
- the change to the registered person(s) including:
  - their name and date of birth
  - if they are joining or leaving the organisation
  - their role in the organisation
  - any other changes involving them
  - the date the change(s) take effect

Ofsted said that the aim of the change is to reduce the administrative burden on early years providers. They will aim to respond to emails in five working days and will let you know if they need any further information.
